## Air Quality Operating Permit for Wildcat Compressor Station of XTO Energy Inc

XTO Energy Inc at 22777 Springwoods Village Parkway; Spring, TX 77389 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Wildcat Compressor Station. The owner of this plant is XTO Energy Inc. The exact location of the facility is at latitude and longitude decimal degrees: 32.201944, -103.777778 Datum: WGS 84. To aid in locating this facility, the approximate location is 17 miles East of Malaga in Eddy County, NM. This application file has been assigned an Operating Permit Number P290 and TEMPO Agency Interest ID No. 38056. This is an additional publication of Legal Notice due to significant changes made in the previous analysis and proposed permit which have occurred since the original Legal Notice was published in September 2022.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to separate oil, natural gas, and water from a nearby pipeline; temporarily store condensate onsite until it is removed via truck or pipeline; and compress dehydrated natural gas for transport through the sales line.

This operating permit application is for a new operating permit. Per 20.2.70.401.C.(4) NMAC, the TV operating permit incorporates the most recent New Source Review (NSR) Permit 7474M2, issued on February 11, 2022.

The emissions, as established in NSR Permit 7474M2 and brought forward into this permit are as follows. Parentheses note changes in emissions from previous construction permit. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 200.9 tpy (no change); Carbon Monoxide (CO) at 247.7 tpy (no change); Volatile Organic Compounds (VOC) at 267.5 tpy (no change); Sulfur Dioxide (SO<sub>2</sub>) at 19.5 tpy (no change); Particulate Matter 10 microns or less (PM<sub>10</sub>) at 17.1 tpy (no change), and Particulate Matter 2.5 microns or less (PM<sub>2.5</sub>) at 17.1 tpy (no change); and greenhouse gas (CO<sub>2</sub>e) > 75,000 tpy.

There are no changes to the existing air emission limits in this permitting action.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 38, 50, 61, 70, 71, 72, 73, 77, and 82; 40 CFR 60 Subparts A, JJJJ, OOOOa; 40 CFR 63 Subparts A, HH, and ZZZZ; and the New Mexico Air Quality Control Act. If EPA's 45-day review of the re-proposed permit is completed with no further comments, NMED's preliminary intent is to issue the air quality operating permit.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
