Air Quality Operating Permit
for Pump Canyon VV Compressor Station of Harvest Four Corners LLC

Harvest Four Corners LLC at 1755 Arroyo Dr; Bloomfield, NM 87413 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Pump Canyon VV Compressor Station. The owner of this plant is Harvest Four Corners LLC. The exact location of the facility is at latitude and longitude decimal degrees: 36.794722, -107.733333 Datum: NAD27. To aid in locating this facility, the approximate location is 7 mi NE of Blanco in San Juan County, NM. This application file has been assigned an Operating Permit Number P001-R5 and TEMPO Agency Interest ID No. 1183.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to compressor natural gas for pipeline transmission.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves renewal of the Title V permit. There have been no modifications or physical changes to the facility since the pervious Title V permit P001-R4.

The estimated maximum air pollutant emissions to the atmosphere, from this facility after the requested operating permit is issued, are as follows. Parentheses note changes in emissions from previous operating permit – P001-R4. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO_x) at 153 tpy (no change); Carbon Monoxide (CO) at 257.9 tpy (no change); Volatile Organic Compounds (VOC) at 45.9 tpy (-10); Sulfur Dioxide (SO₂) at 5.0 tpy (-0.9); Particulate Matter 10 microns or less (PM₁₀) at 3.3 tpy (no change), and Particulate Matter 2.5 microns or less (PM_{2.5}) at 3.3 tpy (no change); and greenhouse gas (CO₂e) 51,726 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 50, 61, 70, 71, 72, 73, and 74; 40 CFR 50; 40 CFR 63 Subparts [A and ZZZZ]; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before December 17, 2023.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P001-R5 by contacting Urshula Bajracharya at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816, or by email at Urshula.Bajracharya@env.nm.gov. Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
