Air Quality Operating Permit
for 3B-1 Turley Compressor Station of Enterprise Field Services, LLC

Enterprise Field Services, LLC at PO Box 4324; Houston, TX 772104324 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its 3B-1 Turley Compressor Station. The owner of this plant is Enterprise Field Services, LLC. The exact location of the facility is/will be at latitude and longitude decimal degrees: 36.767861, -107.790278 Datum: WGS84. To aid in locating this facility, the approximate location is 2 miles northwest of Turley in San Juan County, NM. This application file has been assigned an Operating Permit Number P256R2 and TEMPO Agency Interest ID No. 1153.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to compress pipeline quality natural gas for pipeline transmission using one reciprocal internal combustion engine-driven compressor and one electric compressor. This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves renewal of the existing Title V permit.

There are no changes to the existing air emission limits in this permitting action.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 50, 61, 70, 71, 72, 73, and 82; 40 CFR 63 Subparts A and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before September 21, 2024.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P256R2 by contacting Miranda Baldwin at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816, or by email at miranda.baldwin1@env.nm.gov. Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
