## Air Quality Operating Permit for Reveille Compressor Station of Delaware G & P, LLC

Delaware G & P, LLC at 1722 Routh Street, Suite 1300; Dallas, TX 75201 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Reveille Compressor Station. The owner of this plant is Delaware G & P, LLC. The exact location of the facility is at latitude and longitude decimal degrees: 32.125875, -103.976947 Datum: WGS84. To aid in locating this facility, the approximate location is 13.05 miles southeast of Loving in Eddy County, NM. This application file has been assigned an Operating Permit Number P303 and TEMPO Agency Interest ID No. 40948.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to compress and dehydrate natural gas.

This operating permit application is for a new permit. Per 20.2.70.401.C.(4) NMAC, this permitting action involves the addition of the following equipment: 2-5000 hp Waukesha 16V275GI Compressor Engines (ENG-1 – ENG-2), 6-3750 hp Caterpillar 3612A4 Compressor Engines, 1-TEG Gylcol Dehydrator and its reciprocating Reboiler, 1-750 bbl Gunbarrel Separator, 2-1000 bbl Condensate Tanks, 1-1000 bbl Produced Water Tank, Condensate and Produced Water Loading, Enclosed Combustion Device, Fugitives, and Startup, Shutdown, Maintenance.

The estimated maximum air pollutant emissions to the atmosphere, from this facility after the requested operating permit is issued, are as follows. The facility is a major, >100,000 tpy  $CO_2e$ , source of greenhouse gas emissions. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 95.4 tpy (No Change); Carbon Monoxide (CO) at 183.6 tpy (No Change); Volatile Organic Compounds (VOC) at 228.9 tpy (No Change); Sulfur Dioxide (SO<sub>2</sub>) at 5.5 tpy (No Change); Particulate Matter 10 microns or less ( $PM_{10}$ ) at 9.8 tpy (No Change), and Particulate Matter 2.5 microns or less ( $PM_{2.5}$ ) at 9.8 tpy (No Change); and greenhouse gas ( $CO_2e$ ) > 75,000 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 38, 50, 61, 70, 71, 72, 73, 75, 77, and 82; 40 CFR 60 Subparts A, JJJJ, Ka, Kb, and OOOOb; 40 CFR 63 Subparts A, HH, and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before August 17, 2025.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and

the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
