Public Involvement Plan: Amendment of 20.3.16 NMAC.

Element 1 – Public Involvement Plan (PIP) Overview

The New Mexico Environment Department (NMED or Department), Radiation Control Bureau (Bureau) developed this Public Involvement Plan (PIP) to increase transparency regarding the decision-making and rulemaking process involved in amending 20.3.16 New Mexico Administrative Code (NMAC).(Title 20 Environmental Protection, Chapter 3 Radiation Protection, Part 16 "Fees for Licensure of Radioactive Materials")

Compliance is one of the Department's core values guiding the positive application of our mission. Addressing violations posing the greatest risk to public health and the environment in a fair, just manner safeguards a level playing field for all regulated businesses. Enforcement of violations and holding those responsible who violate the laws, rules, registrations, and licenses we oversee is the expectation and rights of the communities we serve. An expectation we are dutybound to uphold. The Bureau believes the proposed fee increases will provide the budget needed to effectively operate the program in the best interests of the public. It would provide the Bureau with the necessary resources to hire new employees and purchase new equipment for the health and safety of the public. New Mexico is compelled to meet the requirements to protect the public health and safety with regards to radioactive material within the state agreed upon between the State of New Mexico and the U.S. Nuclear Regulatory Commission (NRC) in the April 3, 1974, Agreement signed by then Governor Bruce King.

The purpose of this PIP is to plan for providing public participation opportunities and information that needed for New Mexicans to participate in the rulemaking.

This PIP integrates information about the potentially affected communities and identifies resources needed by the Bureau to incorporate community participation activities into the decision-making process for rulemaking. The PIP identifies the Department staff and resources needed to accomplish these activities.

Rulemaking may require public participation throughout different stages. The Bureau will meet the public participation requirements for the rulemaking by following this PIP, which includes applicable policy, regulatory and statutory public participation requirements.

In developing this PIP, community participation needs were assessed to ensure the appropriate promotion of public outreach by identifying whether there is a combination of environmental and demographic factors (i.e., low-income community, minority community, limited English proficiency individuals, Linguistically Isolated Households, etc.) that may impact public participation. Hence, this assessment identifies community outreach opportunities for participation and provides for those opportunities.

As much as possible, public participation and informational activities related to the rulemaking will be held within the timelines outlined in the table below. This timeline is tentative and subject to change; activities subject to statutory or regulatory deadlines are noted.

In the timeline for this rulemaking, public comments will be received from December 15, 2023, until the conclusion of the hearing (date to be determined), and there will be at least a 7-day advanced notice for the public meeting and the public hearing, including posting the meeting and hearing information on the Department's website.

During the public comment periods, documents may be reviewed at the repositories listed. Details about planned Bureau outreach are provided in this PIP.

This PIP is a "living" document that may be amended after considering public comments and Feedback and for updates. The Bureau Chief provides final approval of the PIP and amendments.

Element 3 - Regulatory Background for Public Participation

The Department is responsible for environmental management and consumer protection programs. Regarding radiation control, the Department maintains, develops, and enforces rules and standards as provided in the Radiation Protection Act. <u>See</u> Section 74-1-7(A)(5) NMSA 1978 (2000). In addition, the Environmental Improvement Board ("EIB") is responsible for environmental management and consumer protection. Regarding radiation control, the EIB promulgates rules and standards for radiation control. <u>See</u> Section 74-1-8(A)(5) NMSA 1978 (2020).

The Bureau may propose regulations to the EIB for promulgation. Within 60 days of the submission of the proposed regulations, the EIB will determine whether to hold a hearing on the proposed regulations, however, no regulation will be adopted until after a public hearing by the EIB. <u>See</u> Section 74-1-9(A) and (B) NMSA 1978 (1985); <u>see also</u>, 20.1.1.300(A) NMAC (2006).

EIB will issue notice of public hearing on the proposed rulemaking at least 60 days prior to the hearing date. The notice of public hearing will state: (1) the subject of the proposed rule, including a summary of the full text of the proposed rule and a short explanation of the purpose of the proposed rule; (2) a citation to the specific legal authority authorizing the proposed rule and a short explanation of the purpose of the proposed rule; (3) a citation to technical information, if any, that served as a basis for the proposed rule, and information on how the full text of the technical information may be obtained; (4) the statutes, regulations and procedural rules governing the conduct of the hearing; (5) the manner in which persons may present their views or evidence to the board, including the time, place, and information on participating in the public hearing; (6) the location where persons may secure copies of the full text of the proposed rule; (7) an internet link providing free access to the full text of the proposed rule; and, (8) if applicable, that the board may make a decision on the proposed regulatory change at

the conclusion of the hearing. <u>See</u> 20.1.1.301(B) NMAC (2006); <u>see also</u>, Section 14-4-5.2(A) NMSA 1978 (2017); <u>and see</u>, Section 74-1-9(D) NMSA 1978 (1985).

Any member of the public may submit written comments on the proposed rulemaking during the public comment period which will run for 30 days after publication in the New Mexico Register. <u>See</u> Section 14-4-5.3(A) NMSA 1978 (2017). Any member of the public may also testify at the public hearing or submit written statements for the record, in lieu of providing oral testimony. <u>See</u> 20.1.1.304 NMAC (2018).

Element 4 - Location and Demographics of the Community and Stakeholder Groups

To provide for adequate public participation opportunities and meaningful involvement of persons in this rulemaking, the affected communities must first be identified, informed about proposed environmental actions affecting the community, and invited to share their comments and concerns. The EJSCREEN tool developed by the U.S. Environmental Protection Agency (EPA) helps identify communities that are low-income and minority populations that may benefit from a variety of approaches for notification and outreach communication. This information is used to help plan for the community's involvement in the public process for environmental activities or actions.

Demographic indicators were obtained from EPA EJSCREEN, an environmental justice screening and mapping tool, available online at https://www.epa.gov/ejscreen. This rulemaking impacts the entire, non-tribal government portion of the state, which includes a community of 9% Spanish-speakers whose English-speaking ability is "less than very well"¹. The Bureau will provide pertinent information in both English and Spanish in public meeting notices, public comment notices, and other announcements.

Limited-English Proficiency (LEP) Analysis and Plan For the Radiation Technical Advisory Council meeting to review rule revisions of 20.3.16 NMAC

New Mexico Environment Department Radiation Control Bureau

Factor 1: The Number and Proportion of LEP Individuals Eligible to be Served or Likely to be Encountered in the Community of Concern

See Public Involvement Plan (PIP), Table of EJSCREEN Results for the Affected Community.

Conclusions:

1. The number of LEP individuals (persons over the age of 5 who speak English "less than very well" in the affected community) is 171,528.

2. The percentage of LEP individuals in the affected community is 9%.

3. The percentage of linguistically isolated households is 5.2%, slightly less than the statewide average.

4. Spanish is the predominant non-English language spoken by LEP persons.

5. Historical participation: Rule revision of 20.3 NMAC to align with NRC regulations is a common practice for RCB. No one has yet requested placement on a specific mailing list.

Factor 2: Frequency with which LEP Individuals Might Come in Contact with the Program

The department will also establish a website and email informational bulletins periodically. This outreach precedes a formal Department rulemaking process before the Environmental Improvement Board, where the public will have the opportunity to comment. The Department is planning to prepare draft rules by the early fall of 2023 and go before the Board in the late fall or early winter of 2023. LEP individuals might come in contact with the outreach material and may choose to comment before the Board. Considering that 5.2% of the Spanish-speaking population is considered linguistically isolated and that 27% of New Mexicans speak Spanish at home, an identifier of "occasional" is assigned to this factor. A summary of historical participation in activities for this rulemaking is under Factor 1.

Considering that 5.2% of the Spanish-speaking population is considered linguistically isolated and that 27% of New Mexicans speak Spanish at home, an identifier of "**occasional**" is assigned to this factor.

Factor 3: Nature and Importance of the Activity or Service Provided by the Program

The RCB deems the Radiation Technical Advisory Council ("RTAC") and EIB petition for hearing meetings reviewing the rulemaking activity of amending 20.3.16 NMAC "important" to the Department, the impacted community, and the State of New Mexico. The RTAC and EIB petition for hearing meetings reviewing rulemaking activity will help the Bureau and New Mexico to change its rules to align with the NRC Fiscal Year 2021 fees. It is essential to the Department because the requirements must be met to protect public health and safety and provide a means to enforce those requirements. The RTAC meeting approval will be presented to the EIB at the hearing that will be scheduled within 60 days of the EIB petition for hearing. These rulemaking activities are vital to the impacted community, the Bureau believes that the proposed rule revisions will provide for the health and safety of the public, and meet the requirements agreed upon between the State of New Mexico and the U.S. Nuclear Regulatory Commission (NRC) in an April 4, 1974 Agreement <u>https://www.nrc.gov/cdn/nmss/pdf/nmagreements.pdf</u> that Governor Bruce King signed.

The RCB considers the RTAC and EIB petition for hearing meetings reviewing the rulemaking activity of amending 20.3.16 NMAC "important" to the Department, the state as a whole, and the impacted community.
