

SCOUNDREL IDENTIFIED AT DACC WATER TECH PROGRAM

Doug Roby, DACC

After 30 some years at Dona Ana Community College, I was finally cornered by Bob Gott the other day and asked to “come clean” about all the student abuse I administered to all those wholesome young lads and lassies desiring a cushy job in the utilities department. Originally from Rockford, Illinois, my wife and I came to New Mexico on vacation in November 1974 and by December, I was hired by Max Summerlot to teach laboratory analysis for a new vocational program called Utility Operator Training Program. Nobody knew what Utility Operator Training Program was, so we eventually changed it to Water



Technology. The program and building were originally funded through money from the Clean Water Act and CETA obtained by a group of forward thinking operators and engineers. Max Summerlot, Jesse Lundsford, John Hernandez, Clyde Vigil, Bob Sparks, Ed Archuleta and several others I can't remember had a vision of an EPA training center that would provide trained operators to help fulfill municipal utility staffing needs. Each county in the State was encouraged to send a student to the school.

CETA (Comprehensive Employment & Training Act) provided funding for the first group of 10 students. It was pretty funny, the students were making more money through their financial aid than I was making as their instructor and we were about the same age. My wife had challenged me to grow a beard the previous summer, so I decided to keep it hoping that I would look at least a little older than the students. My first chance to abuse the students came early in my first semester. I'm sure it was Art Torrez and Bob Gott who decided they didn't have to come to class on time, so I used my power as "King" to lock them out of the classroom to demonstrate the importance of timeliness. The second group of students even went on strike when their CETA checks were late. About the same time, Gene Nelms, an English Major, was hired to teach maintenance.

This completed our original staff for several years until Max Summerlot died. Gene became Program Coordinator, and Cynthia Hiers-Robinson was hired to teach wastewater operations and microbiology.

I have always been blessed to work with tremendously dedicated friends and colleagues. Max, Gene, Cynthia, Jake Hands, and now Terry Mount have all tried to get me to be less abusive to students

but they haven't succeeded. In fact, Terry is now even more abusive than I am. Imagine expecting students to complete assignments on time, perform analysis correctly and accurately, pay attention to details, work together, and actually think for themselves. Her expectations are much too high, but it allows for a great deal of joy watching students struggle over and over again. I always told students they could address me as "king" or "your majesty", but instead they would call me LSD (little

short dude) or Papa Smurf. How rude! You can only imagine what they call Terry. They have learned to duck when she points her index finger at them.

The saddest part of my career came with the passing of Cynthia Hiers-Robinson. We worked together for almost 25 years and she literally gave her life for this program. Her concern for students goes beyond description. A tear still comes to my eye, every time I open her old office and still see all the clutter and papers scattered everywhere.

Certainly the hardest part of teaching is keeping up with technology and regulations. My latest endeavor has been to work with Mike Coffman on the Laboratory Certification Study Guide. I will be interested in getting feedback from laboratory technicians

DOUG.....As King

Back when I was in school, we all called Doug "Papa Smurf" because he always ensured that everything in his lab went as the leader demanded.

The second goal is to provide guidance on quality control issues and finally to get each laboratory to the same baseline competency level. Hopefully, the certification program will increase technician skills and produce consistently valid data within all laboratories in New Mexico.

All in all, teaching in the Water Technology Program has been very satisfying and being a scoundrel goes with the job. This is a great career field, with great long-term growth potential but unfortunately not very glamorous and doesn't get the marketing it needs. Every time a student graduates and becomes a successful operator/manager/lab tech, my abusive behavior is reinforced and I continue to be an unremorseful scoundrel.

DOUG.....As a Human Being

In 1989 Doug hosted a Halloween Party at his home. It was a great party and I was impressed that Doug had welcomed students into his home and personal life. What really defined Doug's character and cemented my respect for him was the attitude he showed during two memorable moments at the party. We were unloading metal folding chair from the back of a truck and Doug grabbed two chairs from the bottom (I handled down the chairs sideways) and they separated with one swinging inward to hit him in the top of the head cutting and bruising him. I apologized and his response was, "I won't need my costume now". The second moment occurred when a fellow student, Gary Pruitt showed up about half way through the party. He began to back up his truck to park and in the process ran over the well leaving Doug's house without water. Doug's response was simply that as future operators we would have to repair the well and plumbing, "consider it On-the-Job-Training". We never did repair the well and he egged me about the bruise and cut on his head for the next couple of years, but he has always been there to provide guidance and assistance. But I don't believe he has ever had another party at his house.

The application **should be filled out completely**, even though you are currently certified and have a file with us, I don't always know how long you've been in your position current or otherwise. Most of you think that because "*it's on file*" you don't have to complete the application. **Wrong!** I don't have time to be digging into 3,000 operator files to search for information that should be on the application.

ERG PROGRAM PROVIDES FREE OPERATOR TRAINING!!!

The Expense Reimbursement Grant (ERG*) program provides operator training and funding for small drinking water supply system representatives. This program offers free training sessions conveniently located throughout the state. Eligible attendees will be reimbursed for expenses related to attending the training sessions, and for the certification exam fee.

Training focuses on water certification levels: Small Water (SW), Small Water Advanced (SWA), Level 1 Water Supply (WS1) and Level 2 Water Supply (WS2). Eligibility for reimbursement is based on the following criteria: Must be attending training on behalf of a water system less than 3301 persons, water system must be either a community or non-transient non-community water system and only two persons per eligible water system may receive reimbursement.

Paid and unpaid small water system representatives may be reimbursed for mileage to and from the training sessions. Only one person per vehicle may claim mileage expenses. Mileage reimbursement is set at \$0.32 per mile and is determined using map miles from your house to the training session.

Unpaid volunteer small water system representatives may receive reimbursement for actual meal and lodging expenses, up to limits set by the State, (up to \$135 per night for lodging, including taxes and fees, and \$30 per day for meals).

Certification exam fees will also be reimbursed for all eligible paid and unpaid small water system representatives. You may receive reimbursement for exam fees up to three times from this program.
