

**ADMINISTRATIVE COMPLIANCE ORDER REQUIRING COMPLIANCE  
AND ASSESSING A CIVIL PENALTY**

The Water Protection Division (“Division”) of the New Mexico Environment Department (“Department”) issues this Administrative Compliance Order (“Order”) to Matador Production Company and San Mateo Midstream (“Respondents”) on behalf of the Department’s Surface Water Quality Bureau (“Bureau”). This Order is issued pursuant to Section 74-6-10 of the Water Quality Act (“Act”) and the Interstate and Intrastate Standards for Surface Water (“Regulations”) found at 20.6.4 NMAC. The Secretary of the Department has delegated the authority to issue this Order to the Director of the Division.

**FINDINGS OF FACT**

1. Respondent Matador Production Company is an oil and gas exploration and production company, with its headquarters in Dallas County, Texas. Respondent San Mateo Midstream, LLC is a joint venture formed by Matador Resources Company and Five Point Capital Partners to operate and grow midstream assets in the Delaware Basin.
