**ORDER CONTINUING HEARING AND REVIEW OF SETTLEMENT AGREEMENT**

**THIS MATTER** having come before the New Mexico Water Quality Control Commission (“Commission”) at its regular meeting on September 8, 2020 on the Joint Motion to Continue Hearing of the New Mexico Environment Department’s Water Protection Division and Matador Production Company and San Mateo Midstream, LLC (“parties”), requesting that the adjudicatory hearing in this matter set for September 8, 2020, be continued until the parties submit a Settlement Agreement to the Commission in accordance with 20.1.3.22(B) NMAC. The parties having sufficiently advised the Commission as to the circumstances surrounding completion of the pending Settlement Agreement; and after due deliberation by the Commission:

**IT IS THEREFORE ORDERED** that (A) the adjudicatory hearing in this matter set for September 8, 2020, is continued until the parties submit their proposed Settlement Agreement to the Commission in accordance with 20.1.3.22(B) NMAC, which the Commission will consider at its next regular meeting on October 13, 2020; and (B) the parties submit with their proposed Settlement Agreement for the Commission’s approval a Stipulated Order signed by the parties and

conforming to all the requirements set forth in 20.1.3.22(B)(1) NMAC.
