Occupational Health and Safety Review Commission Minutes of February 8, 2018, Meeting

The meeting of the Occupational Health and Safety Review Commission was held on February 8, 2018, starting at 10:00 a.m. in the Large Conference Room of the Marquez Place Building, 525 Marquez Place Santa Fe, NM.

1. CALL TO ORDER.

Chair C. Bryan Drennan, called the meeting to order at 10:00 a.m. A quorum was established by roll call.

3. APPROVAL OF THE AGENDA.

4. APPROVAL OF MINUTES OF October 19, 2017.

<u>MOTION:</u> Mr. Carter moved to approve the minutes of October 19, 2017, as presented. Chair Drennan seconded the motion. The motion passed by a voice vote.

5. Introduction of new Administrator and new legal Counsel.

Chair Drennan introduced John Kreienkamp, Commission Counsel. Mr. Kreienkamp gave a brief description on his work background.

6. Adoption of OHSRC 2018 Open Meetings Act Resolution.

Mr. Kreienkamp, Commission Counsel addressed the Occupational Health & Safety Review Commission Open Meetings Act Resolution for 2018.

MOTION: Chair Drennan moved to adopt the Occupational Health & Safety Review Commission Open Meetings Act Resolution for 2018. Mr. Carter seconded the motion. The motion passed by a voice vote.

7. DISCUSSION OF OPEN/PENDING OHSRC CASES.

Chair Drennan reviewed the list of cases provided by the Administrator (2016 and 2017). Mr. Genoway gave an up-date on the OHSB pending cases, the recent Regulatory changes and the New Mexico Regulations for 2018.

8. OSHA 17-28. Hearing on the matter of NMED v. Comfort Inn & Suites. George Anthony Bleus, Esq. Zorik Haruthunian, Esq., Bleus & Associates on behalf of affected employee. Objection Hearing. The Commissioners may adjourn into Closed Executive Session to discuss this matter pursuant to Section 10-15-1(H)(3), NMSA 1978 of the Open Meetings Act.

Chair Drennan called the hearing to order. Mr. Carter, Commissioner and Mr. Kreienkamp, Commission Counsel introduced themselves. The hearing was conducted in accordance with Occupational Health and Safety Act.

Mr. Buchan withdrew his objection.
