

Notice of Docketing, Hearing Determination and Appointment of Hearing Officer

On October 4, 2019, the Environmental Health Bureau (“Petitioner”) of the New Mexico Environment Department filed a Petition for Adoption of New Rule 20.10.2 NMAC – Hemp Post-Harvest Processing and Request for Hearing with the Hearing Clerk. The foregoing matter is hereby docketed as NMED 19-41 (R).

The Secretary of the Environment Department (“Secretary”) grants a hearing for the foregoing matter, pursuant to 20.1.9.12.A(4). The hearing will be conducted pursuant to 20.1.9 NMAC and all other applicable law. The hearing shall be in Santa Fe, New Mexico to begin on December 2, 2019, and continue as necessary. The venue for the hearing will be determined at a later point.

Pursuant to NMAC 20.1.9.8.B, the Secretary of the Environment shall appoint a Hearing Officer. The Secretary hereby appoints Felicia Orth to serve as Hearing Officer. The Hearing Officer shall exercise all powers and duties granted under the New Mexico Environment Department Rulemaking Procedures found in 20.1.9 NMAC and all other applicable law. The Hearing Officer will conduct a public hearing and submit a report and recommendation to the Secretary who will issue the final order on the proposed regulatory addition.
