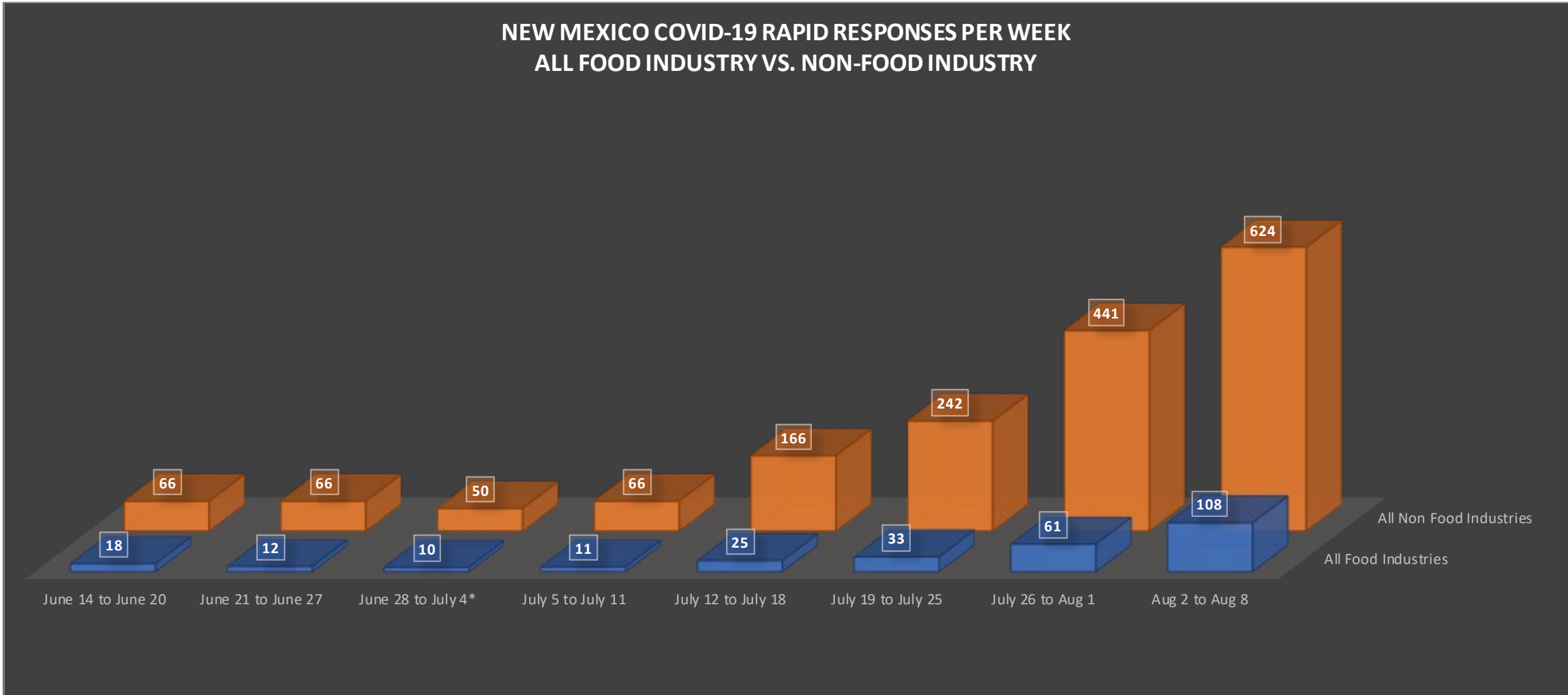
ALL NEW MEXICO COVID-19 RAPID RESPONSES SINCE MAY 2020

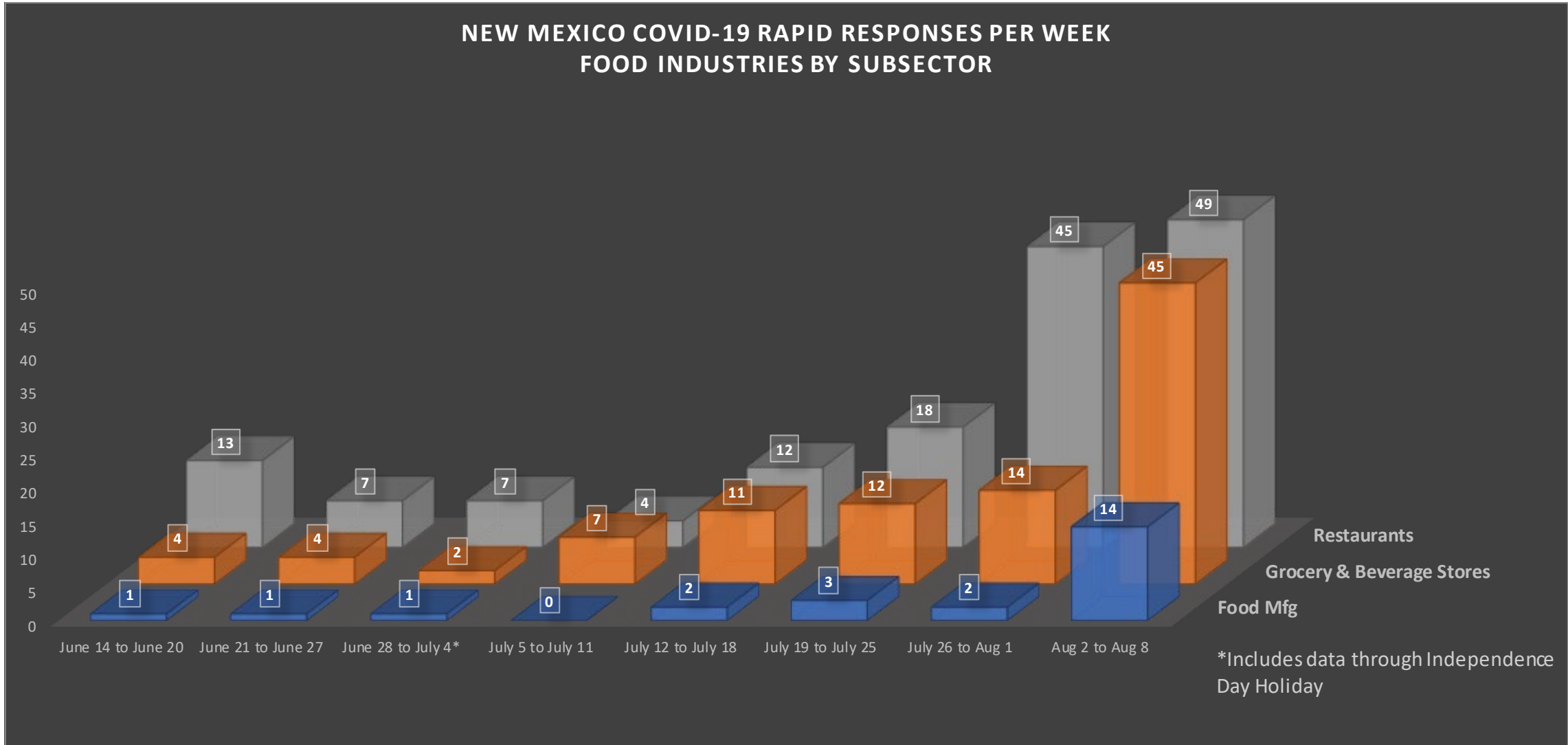
