Preliminary Determination for an Air Quality Permit for  
Camino Real Environmental Center

Camino Real Environmental Center at PO Box 580, Sunland Park, NM has submitted an air quality permit application to the Air Quality Bureau (AQB), New Mexico Environment Department (NMED) for an air quality permit to modify Camino Real Landfill. The application file has been assigned Permit No. 7592M1 and TEMPO Agency Interest No. 167. The exact location of the facility is at latitude and longitude decimal degrees: 31.795447, -106.592022 Datum: NAD83. This facility is located at 1000 Camino Real Blvd, Sunland Park, New Mexico, in Dona Ana County.

The Camino Real Landfill is a solid waste landfill that receives household trash; commercial trash, for example from schools, restaurants, and nearby businesses; and industrial waste. It is also permitted to operate a petroleum hydrocarbon land farm on a portion of the site (e.g. soil contaminated with spilled motor oil); a recycling center; and a flare used to combust the landfill gas that comes from the decomposition of the waste. This landfill is not allowed to accept hazardous or medical waste. The Four Peaks Energy Plant is located on the same property and includes two engines that can also combust the landfill gas to produce commercial electrical power.

Previously, the facility received an air quality construction permit and is in operation.

This construction permit application is for a permit modification. This modification incorporates its previous construction air quality permit number 7592R1, which included the addition of a portable diesel fuel tank added to the exempt source list. The modification consists of new addition of five engines to support landfill operations such as light towers and air compressors.

Total air pollutant emissions to the atmosphere are estimated to be approximately as follow: Parentheses note changes in emissions from previous operating permit – P186LR3M1. The emissions for the facility are expressed in tons per year (tpy). Nitrogen Oxides (NO<sub>x</sub>) at 39.1 tons per year (tpy) (+12.0); Carbon Monoxide (CO) at 135.5 tpy (+11.8); Volatile Organic Compounds (VOC) at 56.7 tpy (+10.5); Sulfur Dioxide (SO<sub>2</sub>) at 9.1 tpy (+2.9); Particulate Matter (PM) at 86.4 tpy (+1.0); Particulate Matter 10 microns or less (PM<sub>10</sub>) at 25.1 tpy (+1.0); and Particulate Matter 2.5 microns or less (PM<sub>2.5</sub>) at 3.9 tpy (+1.0); and greenhouse gas (CO<sub>2e</sub>) > 75,000 tpy. These emission estimates could change slightly during the course of the Department's review of the application.

The NMED has conducted a preliminary review of the information submitted with the permit application. The preliminary review and applicant's analysis of ambient air quality impacts indicates that the facility's air emissions will meet the air quality standards for NO<sub>x</sub>, CO, SO<sub>2</sub>, PM, PM<sub>10</sub> and PM<sub>2.5</sub>. VOCs are a pre-cursor to ozone and the NMED does not require an individual ozone ambient impact analysis for each application. To determine compliance with national ambient air quality standards for ozone, NMED uses air monitors to monitor ozone concentrations. A full review will evaluate the estimated emission rates for the pollutants listed in this public notice and determine compliance with ambient air quality requirements and standards.

Based on the applicant's analysis, a preliminary determination is that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 3, 7, 61, 64, 70, 71, 72, 73, 77, and 82; 40 CFR 50; 40 CFR 60 Subparts A and Cf ; 40 CFR 63 Subparts A and AAAA; 40 CFR 68; 40 CFR 82; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality permit on or before October 20, 2021.

To ensure compliance with state and federal air regulations, the permit is expected to include conditions that limit the emissions and conditions that will require record keeping and reporting to the Department.

Due to the public health emergency order, certain NMED offices are closed to the public. The permit application is available for review on the AQB Public Notices of Permitting Actions website [www.env.nm.gov/air-quality/public-notice-of-permitting-actions/](http://www.env.nm.gov/air-quality/public-notice-of-permitting-actions/).

All interested persons have thirty (30) days from the date this notice is published, to notify the Department in writing of their interest in the permit application. The written comments should refer to the company name, facility name and Permit No. (or send a copy of this notice along with your comments). The written comments shall state the nature of the issues raised and how it relates to the requirements of applicable state and federal air quality regulations and the Clean Air Act. The Department will notify all persons, who have provided written comments as to when and where the Department's analysis may be reviewed. Although all written comments will be made part of the public record, any person who does not express interest in writing before the end of this first thirty (30) day period will not receive such notification.

If the Department receives written public comment before the end of the Department's thirty (30) day public notice, the Department's analysis will be made available for review for thirty (30) days at the NMED district or field office nearest to the source before the permit will be issued. Written comments on the analysis or permit application may be submitted to the Department during this second thirty (30) day period or at any time before the permit is issued or denied.
