**JOINT STIPULATION REGARDING POST HEARING SUBMITTALS FILING
DEADLINE**

Amigos Bravos, the Gila Resources Information Project (“GRIP”), the New Mexico Environment Department (“NMED”), the City of Roswell, Laun-DRY, Los Alamos National Security, LLC (“LANS”), William C. Olson, the New Mexico Energy, Minerals and Natural Resources Department, the Department of Defense, the New Mexico Municipal League Environmental Quality Association Subsection, the Dairy Group for a Clean Environment and the Dairy Producers of New Mexico (jointly the “Dairies”), the New Mexico Mining Association, the New Mexico Copper Corporation, American Magnesium, LLC, and Rio Grande Resources Corporation (collectively the “Parties”), by and through undersigned counsel, hereby submit this Joint Stipulation regarding the filing deadline for post hearing submittals, including written closing arguments and findings of fact and conclusions of law. In support of this stipulation, the Parties agree that:

1. The transcript for the WQCC’s hearing on NMED’s Petition to Amend 20.6.2 NMAC, held November 14, 2017 through November 17, 2017, became available on December 5, 2017. Pursuant to the order of the Hearing Officer, the Parties have sixty (60) days from receipt of hearing transcript to file post hearing submittals, including a written closing argument and proposed findings of fact and conclusions

of law with the WQCC. Therefore, the deadline to file post hearing submittals is February 5, 2017.

2. Due to scheduling conflicts, legal counsel for Amigos Bravos and GRIP proposed an extension of the February 5, 2017 filing deadline to February 16, 2017.
3. All of the Parties concurred with the deadline extension. Therefore, the Parties jointly submit this Stipulation to a February 16, 2017 filing deadline for post hearing submittals, as well as the attached Proposed Order.
