REVISED PROCEDURAL ORDER

In conducting the hearing for Amendments to Ground and Surface Water Protection Regulations, 20.6.2 NMAC, the Hearing Officer shall follow the New Mexico Water Quality Control Commission's (Commission) Rulemaking Procedures at 20.1.6 NMAC. Pursuant to 20.1.6.100.B NMAC, the additional requirements described in this Procedural Order shall also apply. This Procedural Order should be read with the Scheduling Order published concurrently. There will be a final pre-hearing scheduling teleconference on Friday, October 13, 2017, at 10 A.M. to set the order of testimony, and to address any other scheduling issues that may arise prior to the hearing before the Commission, which will commence at 9:00 A.M. on November 14, 2017. An order setting the October 13, 2017 pre-hearing teleconference will be issued prior to that date.

I. Filing and Service of Documents

In lieu of the filing requirements of 20.1.6.104.B(1) NMAC, any person filing any document shall provide the Commission administrator with an original and 12 copies of the document; of these copies, two must be hard copies and ten may be submitted electronically.

II. Notice of Positions Taken by The Parties on Proposed Amendments

No later than July 27, 2017, non-petitioning parties shall file a statement indicating their support of, opposition to, or no position taken on the amendments proposed by the New Mexico Environment Department ("NMED") in its Petition filed May 1, 2017.

III. Proposed Amendments Not Contained in NMED's Petition

No later than July 27, 2017, non-petitioning parties shall file any proposed amendments to 20.6.2 NMAC not contained in NMED's Petition, but limited to logical outgrowths of NMED's proposed amendments. Such proposed amendments shall be accompanied by a statement of reasons for the proposed regulatory change.

IV. Technical Testimony

Full written direct and rebuttal technical testimony, consistent with the provisions of 20.1.6.202 NMAC, shall be submitted prior to the hearing. Written direct technical testimony shall be submitted by September 11, 2017. Written rebuttal technical testimony shall be submitted by October 13, 2017.

V. Exhibits

In lieu of the filing provisions of 20.1.6.302.A NMAC, any person offering an exhibit at the hearing other than a document filed and served before the hearing shall provide at least an original and 12 copies for the commission, and a sufficient number of copies for every other party

VI. Dispositive Motions

Any dispositive motions shall be filed no later than September 29, 2017, with Response due within 15 days, on October 16, 2017, and a Reply by the moving party, if any, due within 10 days after service of the Response, but no later than October 26, 2017.
