MOTION FOR STAY OF COLLECTION OF CIVIL PENALTIES PENDING APPEAL

Respondents Abel Villalpando and Creekside Dairy, LLC (collectively "Respondents"), by and through their attorneys of record, Miller Stratvert P.A. (Richard L. Alvidrez and Elizabeth M. Reitzel), hereby move the New Mexico Water Quality Control Commission ("Commission") to stay collection of all civil penalties in Case No. WQCC 17-07(A) until the final disposition of the appeal of this matter pending before the New Mexico Court of Appeals as Case No. A-1-CA-37623. The Complainant, New Mexico Environment Department, Groundwater Quality Bureau ("Complainant"), does not oppose this motion. As grounds for this Unopposed Motion, Respondents state as follows:

INTRODUCTION

 On August 17, 2018 the Commission issued its *Final Order* in case WQCC 17-07(A), requiring Respondents to pay \$226,800. 2. On September 14, 2018, pursuant to NMSA 1978, Section 74-6-7 (1993), 20.1.3.21(F) NMAC and Rule 12-601 NMRA, Respondents filed an appeal of this matter with the New Mexico Court of Appeals.

3. Pursuant to 20.1.3.21(F) NMAC and NMSA 1978, Section 74-6-7(C), the Commission has the authority to order the stay of a Final Order on appeal pending the outcome of the judicial review. NMSA 1978 §74-6-7 (1993).

4. A stay of collection of the civil penalties under the Final Order is necessary to enable Respondents to appeal the *Final Order*. Additionally, at this time payment of the civil penalties is excessively burdensome for the Respondents.

5. The Complainant does not oppose this Motion and notes that in the event of a successful appeal by Respondents that it would be burdensome to requisition a refund of any payment of the civil penalties from the New Mexico General Fund. However, by agreeing to this Motion, Complainants do not concede the merits of the Respondents' appeal of the *Final Order*.

WHEREFORE Respondents Abel Villalpando and Creekside Dairy, LLC, respectfully request that the Commission grant this Motion in Case No. WQCC 17-07(A) pending the final disposition of the appeal of this matter in Case No. A-1-CA-37623.
