Item #2: Approval of Agenda

ACTION: Ms. Herrera made a motion to approve the agenda. Ms. Wardwell

seconded. Motion carried unanimously.

Item #3: Public Comment Period – 9:30am – 10:00am

Mr. Chris Mechels introduced himself to the Board and stated that he likes the fact that EIB information is on the web page and he feels that the Board is going in a very positive direction. Mr. Mechels stated he has one concern that three members of the Board do not have Financial Disclosure Sheet available through the Secretary of States Office.

Item #4: Approval of July 1, 2003 meeting minutes

ACTION: Mr. Green made a motion to approve the June 12-13, 2003 minutes as

amended. Ms. Herrera seconded. Motion carried unanimously.

Item #5: The New Mexico Environment Department's request for a hearing on proposed revisions to 20.2.75 NMAC – Construction Permit Fees. (EIB 03-07)

Ms. Rita Trujillo requested a 2 hearing be set to begin on October 23rd in the matter of proposed revision to 20.2.75 NMAC – Construction Permit Fees. Ms. Trujillo also requested that the Department be allowed to give a less than 60 day Public Notice.

Mr. Stroud made a motion to set a hearing for October 27th & 28th in the matter of proposed revision to 20.2.75 NMAC and to allow the Department to give a less than 60 day Public Notice. Mr. Stroud noted that Ms. Wardwell would sit as Hearing Officer in this matter. Mr. Tso seconded. Motion carried unanimously.

Item #6: The New Mexico Environment Department's request for hearings on, proposed revisions to and adoption of: (EIB 03-08)

Hearing Officer for the Western Backstop Sulfur Dioxide Trading
Program Hearing 20.2.81 NMAC & Notice of Intent and Emission
Inventory Hearing 20.2.73 NMAC. Ms. Gay Dillingham will sit as
Hearing Officer for the Open Burning Hearing 20.2.60 NMAC. Ms.
Wardwell seconded. Motion carried unanimously.

Item #7: Continuation of hearing of and possible decision to consider Proposed Amendments to Title 20, Chapter 4, Part 1 of NM Administrative Code. (EIB 03-02)

Mr. Chuck Noble, Counsel for the Department, gave a brief background as to what occurred at the beginning of the hearing and concluded with a brief closing statement.

Ms. Gay Dillingham, Hearing Officer, announced that the record is now closed.

ACTION: Mr. Tso made a motion to approve the Proposed Amendments to Title
20, Chapter 4, Part 1 of the New Mexico Administrative Code. Ms.
Wardwell seconded. Motion carried with 1 abstention by Mr.
Clifford Stroud.

Ms. Dillingham made a motion to adopt the Statement of Reasons as proposed by the Department. Mr. Tso seconded. Motion carried with 1 abstention by Mr. Clifford Stroud.

Item #8: Hearing of and possible decision to consider Proposed Amendments Parts 1, 3, 4, 12, 13 and 15 of the New Mexico Radiation Protection Regulation (20.3 NMAC). (EIB 03-03)

A public hearing was held at the New Mexico State Capitol Building in Santa Fe on August 5, 2003 regarding Petition No. EIB 03-03 at approximately 11:30 a.m. In attendance were Clifford Stroud, Hearing Officer, and the Board Members listed above.
