The Chair called the meeting to order at 10:00 a.m.

#### Item 1. Roll Call

Roll was taken and it was noted that a quorum was present.

Item 2. Approval of Agenda

#### Item 6. Public Comment

Chair Green called for public comment at which time, Link Summers, individually, Carlos Romero, Division Director of NMED's Environmental Health Division, and Cecilia Abeyta, representing the New Mexico Farm and Livestock Bureau, indicated their respective wish to speak to the Board. Mr. Green stated that each person would have five minutes to make comments.

Mr. Summers noted receipt of the Liquid Waste Program fund report from NMED as well as mentioning IPRA requests he has filed with the Department and correspondence from the Department's Office of General Counsel regarding those requests. Additionally, he brought up what he feels is a real need to monitor individuals in the liquid waste disposal business that make false claims in their advertising.

Carlos Romero noted that the Liquid Waste Program fund report had been delivered to the Board as well as correspondence dated September 23, 2008, from Clancy Roberts, Chief Financial Officer of NMED, relating to previous financial misconduct allegations made by Link Summers with respect to the Liquid Waste Fund. Mr. Romero indicated that he was available to answer any questions the Board might have relating to either matter. Various members indicated their appreciation for the fund report.

Ms. Abeyta asked that the Board consider an addition to the proposed regulations in EIB 08-11 (R), the adoption of new field citation procedures. She stated that the Farm Bureau would like to see an initial warning provision in the regulations that would be effective prior to the issuance of a citation.

Item 7. Request for hearing in re: Proposed revisions to 20.2.99 NMAC, EIB 08-15 (R), Conformity to the State Implementation Plan of Transportation, Plans, Programs and Projects. Bill Grantham, NMED/OGC; Gail Cooke, NMED/AQB.

Mr. Grantham stated that he and Ms. Cooke were before the Board to request a hearing in EIB 08-15 (R) at the January 5, 2009 meeting. A discussion followed relating to the Board's January 2009 schedule. It was agreed that since the Bureau did not have a time constraint with respect to these amendments, the hearing would be set on the Board's April 6, 2009 agenda.

Action: Ms. Bearden moved that the Board set a hearing in EIB 08-16 (R), Conformity to the State Implementation Plan of Transportation, Plans, Programs and Projects on the April 6, 2009 meeting agenda.

Item 8. Request for Hearing in re: Proposed amendments to 20.3.1, 20.3.3, 20.3.4., 20.3.7, 20.3.13 and 20.3.15 NMAC, EIB 08-16 (R), Radiation Protection Rules. Bill Grantham, NMED/OGC; Daniela Bowman, NMED/RCB.

Mr. Grantham stated that he and Ms. Bowman were before the Board to request a hearing in EIB 08-16 (R), Radiation Protection Rules at the Board's January 5, 2009 meeting. The Board, Mr. Grantham and Ms. Bowman discussed the timelines relating to this hearing and the need for the January agenda setting.

At 11:10 a.m., the Chair announced that the hearing in the above-referenced matter would commence and because Mr. Peters had been delayed in Dallas, he would act as Hearing Officer for this matter. Kathy Townsend Court Reporters transcribed the hearing. All Notices of Intent to Present Technical Testimony were filed and are available for review, as well as public comment correspondence and the hearing transcript in the office of the Environmental Board Administrator, New Mexico Environment Department, 1190 St. Francis Drive, Runnels Building Room N2150, Santa Fe, New Mexico 87505.

The hearing concluded at 2:30 p.m. and the meeting resumed.

The Board conducted lengthy deliberations regarding the proposed field citation procedures and the ramifications of those procedures on the State's citizens and businesses.

The following changes were made to the proposed regulation 20.2.90 NMAC:

Mr. Green moved that the following language amend § 111, 20.2.90.111 NMAC, "Penalties. First time violators of the field citation who demonstrate cooperation in compliance may be fined up to one hundred dollars per violation. First time violators of the field citation rule who fail to demonstrate cooperation in compliance may be fined up to five hundred dollars per violation. Multiple time violators of the field citation rule who demonstrate cooperation in compliance may be fined up to five hundred dollars per violation. Multiple time violators of the field citation rule who fail to demonstrate cooperation in compliance may be fined up to one thousand dollars per violation. Provided, however, that penalties assessed in a field citation shall not exceed one thousand dollars per day per violation or a maximum of fifteen thousand dollars. In determining the amount of penalty to be assessed pursuant to this section, the person issuing the field citation shall take into account the seriousness of the violation, any good-faith effort to comply with the applicable requirements

and other relevant factors." Mr. Ghassemi seconded.
