MINUTES OF THE OCTOBER 11, 2002 MEETING

The September meeting of the Environmental Improvement Board (EIB) was held at the City County Government Center in Albuquerque, New Mexico on October 11, 2002. Chairperson Dr. Hilary A. Noskin called the meeting to order at approximately 9:30 a.m.

Item # 1 Roll Call

Item # 2 Approval of the Agenda

ACTION: Ms. Salopek made a motion to approve the agenda as presented. Ms.

Mojtabai seconded. The motion passed unanimously.

Item #3 Approval of the August 23, 2002 and September 13, 2002 Meeting

Minutes.

ACTION: Dr. Ghassemi made a motion to approve the Minutes of the August

23, 2002 meeting as submitted. Mr. Brunson seconded. The motion

passed unanimously.

Ms. Mojtabai recommended the following changes to the September 13, 2002 minutes:

- Page 2, item #4 at the end of the paragraph, replace the word requested with suggested.
- Page 2, item #4 at the end of the paragraph, remove the word combined and add separate but on the same day, in conjunction with one another or combined.

ACTION: Ms. Mojtabai made a motion to approve the Minutes of the September 13, 2002 meeting as amended. Mr. Brunson seconded. The motion passed unanimously.

Item #4 Report on the Implementation Liquid Waste Fee Regulation – Mike Koranda, Director of Field Operations

Mr. Koranda presented a report on the Implementation Liquid Waste Fee Regulation, which was implemented at the November 9, 2001 hearing. Mr. Koranda noted that the amount of fee revenue collected as of October 4, 2002 is \$384,200. Extrapolating this rate of fee collection over one year results in an estimated annual fee amount collected of \$576,300. Mr. Koranda stated that it is the Department's commitment to provide periodic updates on its progress to implement the fee regulation and on other important liquid waste issues. The Department intends to present its next report to the Board on these matters at the hearing on the proposed amendments to the Liquid Waste Disposal Regulations early next year.

Item #5 Petition by the Waste Management of New Mexico, Inc. – In the matter of setting for hearing the Air Quality Operating Permit No. P208L. (EIB 02-12P)

Mr. Virtue requested that the Board set a hearing as soon as possible on the Air Quality Operating Permit No. P208L.

ACTION: Mr. Brunson made a motion to set a hearing for November 21, 2002 on the Air Quality Operating Permit No. P208L. Mr. Salopek seconded. Motion passed unanimously.

Item #6 Decision on the Petition for Hearing for Proposed Replacement of the Drinking Water Regulations Set Forth at 20-7-10 NMAC. (EIB 01-08R)

ACTION: Dr. Ghassemi moved that the Board adopt the Proposed Replacement of the Drinking Water Regulations Set Forth at 20-7-10 NMAC. Mr. Brunson seconded. A roll call was taken and below are the results:
