Dear Colonel Kubinec and Mr. Pike:

NMED's June 4, 2010 letter to the U. S. Air Force (Permittee) required the Permittee to submit all geophysical logs in the quarterly report submitted for the time period in which the logs were generated. The New Mexico Environment Department (NMED) has not received geophysical logs from any borings/wells logged after the third logging mobilization campaign at the Bulk Fuels Facility, which took place during the second quarter 2011.. The Permittee must submit all geophysical logs conducted after the third mobilization, which are listed below and which include, but are not necessarily limited to, those for groundwater monitoring wells, soil-vapor monitoring wells, PneuLog borings, and extraction/injection wells.

NMED has previously requested these logs by letter, unofficial telephone conversations, and most recently, by email sent December 20, 2012. In some cases, the NMED has been informed that logs have been submitted to the NMED, but NMED was not provided information indicating where and in what document(s) the logs can be found.

Geophysical logs that have not been provided to the NMED to NMED's knowledge are listed below.


