The New Mexico Environment Department has received the U.S. Air Force's (Permittee) time-extension request, dated March 22, 2012, for the Kirtland Air Base (KAFB) Facility for submittal of the *Quarterly Pre-Remedy Monitoring and Site Investigation Report for October – December 2011* (Report). Pursuant to Part 1, Section 1.38 of KAFB's Permit, "Upon the Department's written approval, all submittals and associated schedules shall become enforceable under this Permit in accordance with the terms of the Department's written approval, and such documents as approved, shall control over any contrary or conflicting requirements of this Permit." and "The Department may grant extensions of written requests for due dates for submittals of reports and other deliverables, provided that the Permittee includes a written justification showing good cause and a proposed schedule for submittal."


