SUBJECT: Notice of Kirtland Air Force Base Hazardous Waste Permit Modification Request, Public Meeting, and Public Comment Period

1. Kirtland Air Force Base (AFB) holds New Mexico Environment Department (NMED) hazardous waste permit #NM9570024423-OB for an Open Burn Unit at its Explosive Ordnance Disposal Range. Kirtland AFB has permanently discontinued operation at the Open Burn Unit, and has submitted a revised permit closure plan as a Class 3 permit modification request to the NMED Hazardous Waste Bureau.
2. The revised permit closure plan reflects removal of the Open Burn Unit and the placement of final closure and long term monitoring into the Kirtland AFB Open Detonation Unit Permit (Permit # NM9570024423-OD).
3. Kirtland will hold a public meeting regarding the requested permit modifications on Wednesday, July 7, 2010 from 6:00 PM to 8:00 PM at the following location:

4. Notice of the permit modification request was published in the Albuquerque Journal on 20 June 2010, and begins a 60-day written public comment period.
