## <u>Air Quality Operating Permit</u> for Eunice Gas Processing Plant of Versado Gas Processors, LLC

Versado Gas Processors, LLC at 6 Desta Drive Suite 3300; Midland, TX 79705 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Eunice Gas Processing Plant. The owner of this plant is Versado Gas Processors, LLC and is operated by Targa Midstream Services LLC. The exact location of the facility is at latitude and longitude decimal degrees: 32.424944, -103.14725 Datum: WGS84. To aid in locating this facility, the approximate location is 1 mile SE of Eunice in Lea County, New Mexico. This application file has been assigned an Operating Permit Number P109R3M1 and TEMPO Agency Interest ID No. 609.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to receive field natural gas, perform dehydration and removal of carbon dioxide and hydrogen sulfide, and separate natural gas liquids (NGL). The product natural gas and NGL are compressed or pumped to sales pipelines for distribution.

This operating permit application is for a modification. Per 20.2.70.401.C.(4) NMAC, this permitting action involves this Title V Renewal Application with changes from the NSR Modification application 0067-M11, and M11R1.

The emissions, as established in NSR Permit 0067-M11, and M11R1, and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P109R3. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 2606 tpy (-20.0); Carbon Monoxide (CO) at 758.0 tpy (-48.9); Volatile Organic Compounds (VOC) at 269.2 tpy (+19.1); Sulfur Dioxide (SO<sub>2</sub>) at 482.0 tpy (-369.8); Particulate Matter 10 microns or less (PM<sub>10</sub>) at 22.0 tpy (-0.4), and Particulate Matter 2.5 microns or less (PM<sub>2.5</sub>) at 17.7 tpy (-0.4). The facility is a major, >100,000 tpy CO<sub>2</sub>e source of green house gas emissions.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 35, 37, 70, 71, 72, 73, 74, 75, 77, and 82; 40 CFR 50; 40 CFR 60 Subparts A, KKK, and JJJJ; 40 CFR 63 Subparts a, HH, and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before December 17, 2021.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
