20.2.64.7 DEFINITIONS: In addition to the terms defined in 20.2.2 NMAC (Definitions), and those defined in 40 CFR 60 Subpart A, [as used in this Part:] all definitions found in 40 CFR Part 60 Subpart XXX apply to new municipal solid waste landfills (MSWLs) and all definitions found in 40 CFR Part 60 Subpart Cf apply to existing MSWLs. As used in this part:

A. "Active municipal solid waste landfill" or "active MSWL" means an MSWL in which solid waste is being placed or an MSWL that is planned to accept waste in the future.

B. "Closed municipal solid waste landfill" or **"closed MSWL"** means an MSWL in which solid waste is no longer being placed, and in which no additional solid wastes will be placed without first filing a notification of modification as prescribed in 40 CFR 60.7(a)(4). Once a notification of modification has been filed and additional solid waste is placed in the MSWL, the MSWL is no longer closed.

[A.]C. "Existing municipal solid waste landfill" <u>or "existing MSWL"</u> [is an] <u>means an active or</u> <u>closed</u> MSWL meeting the following conditions:

(1) Construction, reconstruction, or modification was commenced [before May 30, 1991] on or before July 17, 2014; and

(2) The MSWL has accepted waste at any time since November 8, 1987, or has additional design capacity available for future waste deposition.

D. "Modification" means in increase in the permitted volume design capacity of an MSWL by either lateral or vertical expansion based on its permitted design capacity as of July 17, 2014. Modification does not occur until the owner or operator commences construction on the lateral or vertical expansion.

[B-]E. "Municipal solid waste landfill [(MSWL)]" or "MSWL" means an entire disposal facility in a contiguous geographical space where household waste is placed in or on land. An MSWL may also receive other types of Resource Conservation and Recovery Act (RCRA) Subtitle D wastes such as commercial solid waste, nonhazardous sludge, conditionally exempt small quantity generator waste, and industrial solid waste. Portions of an MSWL may be separated by access roads. An MSWL may be publicly or privately owned. An MSWL may be new, existing, or a lateral expansion.

[C.]F. "New municipal solid waste landfill" or "new MSWL" [is] means an MSWL that commenced construction, reconstruction, or modification[, or began accepting waste on or after May 30, 1991] after July 17, 2014.

[**D**.]<u>G.</u> "NMOC" means nonmethane organic compounds as measured according to the provisions of [40 CFR 60.754] either 40 CFR 60 Subpart Cf or 40 CFR 60 Subpart XXX. [This] NMOC may include many compounds commonly referred to as VOC (volatile organic compounds) and HAP (hazardous air pollutants). A. [Reporting and Compliance: Except as provided for below, reporting and compliance requirements for existing MSWLs shall be in accordance with 40 CFR 60.757 and 60.758.

(1) Within 90 days of final US EPA approval of this Part, an owner or operator of an existing MSWL shall submit an initial design capacity report in accordance with 40 CFR 60.757(a)(2) to the Department.

(2) Within 90 days of final US EPA approval of this Part, an owner or operator of an existing MSWL, with a design capacity equal to or greater than 2.5 million megagrams or 2.5 million cubic meters, shall submit an NMOC emission rate report in accordance with 40 CFR 60.757(b)(1) and (2) to the Department.

(3) Within 30 months after final US EPA approval of this Part, an existing MSWL with a design capacity greater than or equal to 2.5 million megagrams or 2.5 million cubic meters, and with an NMOC emission rate greater than or equal to 50 megagrams per year shall install a gas collection and control system as specified in 40 CFR 60.752(b).] Requirements for existing (active and closed) MSWLs shall be in accordance with 40 CFR 60 Subpart Cf, except as provided in Subsections B and C below.

B. All reports required in 40 CFR 60 Subpart Cf shall be submitted to the department according to the schedules outlined in that subpart. Additional notifications regarding progress toward meeting the final compliance schedule for control system installation and startup shall be submitted to the department as follows:

(1) Contracts for construction of collection and control systems shall be awarded or orders for purchase of components shall be completed no later than 6 months following submission of the final control plan;

(2) On-site construction or installation of the collection and control system shall be initiated no later than 9 months following submission of the final control plan;

(3) On-site construction or installation of the collection and control system shall be completed no later than 29 months following the submission of an annual NMOC emission rate report showing NMOC emissions equal to or exceeding the emissions threshold in Subpart Cf; and

(4) Initial performance testing shall be scheduled for no later than 150 days following the final compliance date in Subpart Cf.

[B.]<u>C.</u> Exceptions: On a case by case basis, an existing <u>active or closed</u> MSWL may apply for a less stringent emission standard or longer compliance schedule than those otherwise required by this Part, provided that the owner or operator demonstrates to the Department:

(1) Unreasonable cost of control including, but not limited to MSWL age, location, or basic design;

(2) Physical impossibility or impracticability of installing necessary control equipment; or

(3) Other environmental factors specific to the MSWL that make application of a less stringent standard or final compliance time significantly more reasonable.
