

LEGAL NOTICE

For

Air Quality Operating Permit

for Middle Mesa Compressor Station of Enterprise Field Services, LLC

Enterprise Field Services, LLC at PO Box 4324; Houston, TX 77210-4324 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Middle Mesa Compressor Station. The owner of this plant is Enterprise Field Services, LLC. The exact location of the facility is at latitude 36 degrees, 54 minutes, 24 seconds and longitude -107 degrees, 33 minutes, 51 seconds, Datum: NAD 83. To aid in locating this facility, the approximate location is 55 miles northeast of Aztec in San Juan County, New Mexico. This application file has been assigned an Operating Permit Number P204-R3 and TEMPO Agency Interest ID No. 1193.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to compress and dehydrate field natural gas from a gathering system, for pipeline transmission using natural gas-fired reciprocating engines. This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves renewal of the existing Title V permit.

The emissions, as established in NSR Permit 0918-M7, and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P204-R2M1. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO_x) at 77.5 tpy (no change); Carbon Monoxide (CO) at 129.6 tpy (no change); Volatile Organic Compounds (VOC) at 68.7 tpy (no change); Sulfur Dioxide (SO₂) at 2.5 tpy (no change); Total Suspended Particulate (TSP) at 1.7 tpy (no change); Particulate Matter 10 microns or less (PM₁₀) at 1.7 tpy (no change); Particulate Matter 2.5 microns or less (PM_{2.5}) at 1.7 tpy (no change); Total Hazardous Air Pollutants (HAPs) at 26.2 tpy (+0.1); and greenhouse gas (CO₂e) at 22,593 tpy (first time reported).

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 61, 70, 71, 72, 73, and 82; 40 CFR 50; 40 CFR 63 Subparts A, HH and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before June 28, 2018.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P204-R3 by contacting Joseph Mashburn at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
