For

Air Quality Operating Permit

for El Cedro Compressor Station of Williams Four Corners LLC

Williams Four Corners LLC at 1755 Arroyo Drive; Bloomfield, NM 87413 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its El Cedro Compressor Station. The owner of this plant is Williams Four Corners LLC. The exact location of the facility is at latitude 36 deg, 41 min, 21 sec and longitude -107 deg, 24 min, 6.8 sec, Datum: NAD 83. The facility is located approximately 18 miles east southeast of Navajo Dam, Rio Arriba County, New Mexico. To aid in locating this facility, drive east from Bloomfield on Highway 64 to mile marker 100.5, facility is on the left. This application file has been assigned an Operating Permit Number P046-R3 and TEMPO Agency Interest ID No. 1002.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to receive gas from two gathering systems: the San Juan Conventional gathering system and the Manzanares gathering system. Hydrocarbon liquids are captured and transferred to storage tanks where they await transport to market. Both gas streams are compressed before being sent downstream in natural gas pipelines.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves renewal of the existing Title V permit.

The emissions, as established in NSR Permit PSD0340M13R1, and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P046-R2M1. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO_x) at 317.5 tpy (+8.8); Carbon Monoxide (CO) at 444.7 tpy (+12.4); Volatile Organic Compounds (VOC) at 309.8 tpy (+28.0); Sulfur Dioxide (SO₂) at 2.9 tpy (no change); Total Suspended Particulate Matter at 10.4 tpy (no change); Particulate Matter 10 microns or less (PM₁₀) at 10.4 tpy (no change), and Particulate Matter 2.5 microns or less (PM_{2.5}) at 10.4 tpy (no change); and greenhouse gas (CO₂e) 248,441 tpy (not reported).

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 61, 70, 71, 72, 73, 74, 77 and 82; 40 CFR 50; 40 CFR 60 Subparts A, GG, JJJJ and OOOOa; 40 CFR 63 Subparts A and ZZZZ; 40 CFR 64 and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before April 20, 2019.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P046-R3 by contacting Andrew Ahr at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
