

LEGAL NOTICE

For

Air Quality Operating Permit

for Lordsburg Compressor Station of El Paso Natural Gas Company, L.L.C.

El Paso Natural Gas Company, L.L.C. at 5151 East Broadway Suite 1680; Tucson, AZ 85711 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Lordsburg Compressor Station. The owner of this plant is El Paso Natural Gas Company, L.L.C. The exact location of the facility is at latitude 32 deg, 18 min, 59 sec and longitude -108 deg, 36 min, 22 sec, Datum: WGS84. To aid in locating this facility, the approximate location is 3 miles east-southeast of Lordsburg, New Mexico in Hidalgo county. This application file has been assigned an Operating Permit Number P131R4 and TEMPO Agency Interest ID No. 553.

Previously, the facility received an air quality construction permit and is in operation.

The main purpose of the facility is to compress natural gas for pipeline transportation.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permitting action involves renewal of the existing Title V permit and incorporation of significant revisions to the permit since the last Title V permit was issued.

The emissions, as established in NSR Permit PSD2810-M5, and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P131-R3M1. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO_x) at 727.1 tpy (no change); Carbon Monoxide (CO) at 150.0 tpy (-0.03); Volatile Organic Compounds (VOC) at 29.4 tpy (no change); Sulfur Dioxide (SO₂) at 9.2 tpy (no change); Total Suspended Particulate Matter at 12.3 tpy (no change); Particulate Matter 10 microns or less (PM₁₀) at 12.3 tpy (no change); Particulate Matter 2.5 microns or less (PM_{2.5}) at 12.3 tpy (no change); and greenhouse gas (CO₂e) > 75,000 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 61, 70, 71, 72, 73, 74, 77 and 82; 40 CFR 50; 40 CFR 60 Subparts A and GG; 40 CFR 63 Subparts A and ZZZ; 40 CFR 82; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before March 9, 2019.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P131R4 by contacting Andrew Ahr at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
