Air Quality Operating Permit for Maljamar Gas Plant of Durango Midstream, LLC

Durango Midstream, LLC at 2002 Timberloch Place, Suite 110; The Woodlands, TX 77380 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Maljamar Gas Plant. The owner of this plant is Durango Midstream, LLC. The exact location of the facility is at latitude 32 degrees, 48 minutes, 52 seconds and longitude -103 degrees, 46 minutes, 17 seconds , Datum: WGS84. To aid in locating this facility, the approximate location is 3 miles south of Maljamar, NM in Lea County. This application file has been assigned an Operating Permit Number P123-R3 and TEMPO Agency Interest ID No. 565.

Previously, the facility received an air quality construction permit and is in operation. This is a cryogenic natural gas processing plant that removes Hydrogen Sulfide (H₂S) and Carbon Dioxide (CO₂) from field gas and recovers natural gas liquids and residue gas for sale. Per 20.2.70.401.C.(4) NMAC, this permitting action involves renewal of the existing Title V permit.

The emissions, as established in NSR Permit 0316-M11R1, and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P123-R2. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 174.8 tpy (+15.9); Carbon Monoxide (CO) at 150.5 tpy (+59.3); Volatile Organic Compounds (VOC) at 144.9 tpy (+10.9); Sulfur Dioxide (SO₂) at 249.3 tpy (+0.5); Hydrogen Sulfide (H₂S) at 8.0 tpy (-0.5); Total Suspended Particulate (TSP) and/or Particulate Matter (PM) at 6.3 tpy (no change); Particulate Matter 10 microns or less (PM₁₀) at 6.3 tpy (no change), and Particulate Matter 2.5 microns or less (PM_{2.5}) at 6.3 tpy (no change); Total Hazardous Air Pollutants (HAPs) at 10.8 tpy (-7.8); and greenhouse gas (CO₂e) > 75,000 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 61, 70, 71, 72, 73, 77 and 82; 40 CFR 50; 40 CFR 60 Subparts A, Dc, KKK, JJJJ and OOOO; 40 CFR 63 Subparts A and ZZZZ; 40 CFR 64; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before July 21, 2019.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P123-R3 by contacting Joseph Mashburn at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
