Air Quality Operating Permit

for Harvest - 29-6 No2 Central Delivery Point of Harvest Four Corners LLC

Harvest Four Corners LLC at 1755 Arroyo Dr; Bloomfield, NM 87413 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Harvest - 29-6 No2 Central Delivery Point. The owner of this plant is Harvest Four Corners LLC. The exact location of the facility is at latitude 36 deg, 44 min, 42.98 sec and longitude -107 deg, 26 min, 44.09 sec, Datum: WGS84. To aid in locating this facility, the approximate location is 20 miles east of Blanco, New Mexico, in Rio Arriba County. This application file has been assigned an Operating Permit Number P038-R4 and TEMPO Agency Interest ID No. 1007.

Previously, the facility received an air quality construction permit and is in operation. The main purpose of the facility is to compress and dehydrate pipeline quality natural gas for pipeline transmission.

This operating permit application is for a permit renewal. Per 20.2.70.401.C.(4) NMAC, this permit renewal action incorporates all new source review (NSR) permitting actions since the last TV renewal. All NSR actions since the last TV renewal have been Administrative Revisions. NSR 1035-M10R17 retired and removed four internal combustion engines and two dehydrator units. Hence, that action removed enough equipment and removed its corresponding allowable emissions to make the facility a PSD synthetic minor source.

The emissions established in this permit are as follows: parentheses note changes in emissions from previous operating permit P038-R3. Emissions are expressed in tons per year (tpy): Nitrogen Oxides (NO_x) at 159.1 tpy (-140.5); Carbon Monoxide (CO) at 182.9 tpy (-79.7); Volatile Organic Compounds (VOC) at 195.0 tpy (-84.6); Sulfur Dioxide (SO₂) at 0.2 tpy (-0.1); Particulate Matter 10 microns or less (PM₁₀) at 3.6 tpy (-1.8), Particulate Matter 2.5 microns or less (PM_{2.5}) at 3.6 tpy (-1.8); and greenhouse gas (CO₂e) at 83,286 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 61, 70, 71, 72, 73, 77, and 82; 40 CFR 50; 40 CFR 60 Subparts A, JJJJ, and OOOOa; 40 CFR 63 Subparts A, HH, and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before September 14, 2019.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P038-R4 by contacting Jim Nellessen at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
