## <u>Air Quality Operating Permit</u> for Oxy - Indian Basin Gas Plant of OXY USA WTP Limited Partnership

OXY USA WTP Limited Partnership at 5 Greenway Plaza Suite 110; Houston, TX 770460521 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Indian Basin Gas Plant. The owner of this plant is OXY USA WTP Limited Partnership. The exact location of the facility is at latitude 32 deg, 27 min, 50.03 sec and longitude -104 deg, 34 min, 26.82 sec, Datum: WGS84. To aid in locating this facility, the approximate location is approximately 14.5 miles west of Carlsbad, NM in Eddy County. This application file has been assigned an Operating Permit Number P103-R3 and TEMPO Agency Interest ID No. 197.

Previously, the facility received an air quality construction permit and is in operation. This facility is a natural gas processing plant. The major processes associated with the facility are as follows: sour inlet gas stream, Amine sweetening systems, dehydration of sweetened gas, natural gas liquids removal, and compression and transport of NGL and residue gas to the market.

This operating permit application is for a permit renewal and modification. Per 20.2.70.401.C.(4) NMAC, this permitting action incorporates plant modifications authorized by NSR permits 0295M10 and M11 from the Construction permit.

The emissions, as established in NSR Permit 0295-M11, M10, and brought forward into this permit are as follows. Parentheses note changes in emissions from previous operating permit – P103-R2M1. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NOx) at 343.7 (-115.6) tons per year (tpy); Carbon Monoxide (CO) at 180.1 (-206.1) tpy; Volatile Organic Compounds (VOC) at 87.5 (-17.2) tpy; Sulfur Dioxide (SO2) at 83.8 (-1099.4) tpy; Particulate Matter (PM) at 12.4 (-1.5) tpy; Particulate Matter 10 microns or less (PM10) at 7.7 (-1.5) tpy; Particulate Matter 2.5 microns or less (PM2.5) at 10.2 (-1.5) tpy; and greenhouse gas (CO2e) > 75,000 tpy.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance.

The NMED has made a preliminary determination that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 7, 61, 70, 71, 72, 73, 74, and 75; and 40 CFR 60 Subparts A, GG, KKK, OOOO; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before November 03, 2019.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P103-R3 by contacting Joseph Kimbrell at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
