<u>Air Quality Operating Permit</u> for Rio Rancho Landfill of Waste Management of New Mexico

Waste Management of New Mexico at PO Box 15700; Rio Rancho, NM 87174 has submitted an air quality operating permit application to the New Mexico Environment Department (NMED) for an air quality operating permit for its Rio Rancho Landfill. The owner of this plant is Waste Management of New Mexico. The exact location of the facility is at latitude 35 deg, 16 min, 45.17 sec and longitude -106 deg, 40 min, .92 sec, Datum: WGS84. To aid in locating this facility, the approximate location is 2.4 miles south of Rio Rancho City Hall in Sandoval County, New Mexico. This application file has been assigned an Operating Permit Number P208L-R3 and TEMPO Agency Interest ID No. 1128.

Previously, the plant received an air quality construction permit, if one was required, and is in operation or able to operate. The main purpose of this landfill is to accept Municipal Solid Waste.

This operating permit application is for a permit renewal. There are no changes in allowable emissions in this permitting action.

The NMED has conducted a preliminary review of the information submitted with the permit application. This review included evaluation of the emission rates and applicable requirements to determine compliance status.

The NMED has made a preliminary determination that this plant will comply with the requirements of New Mexico Administrative Code 20.2.7, 20.2.64, 20.2.70, 20.2.71, 20.2.73, 20.2.77, 20.2.82, the New Mexico Air Quality Control Act, 40 CFR 50, 40 CFR 60 Subparts A and WWW, and 40 CFR 63 Subparts A and AAAA. Therefore, the preliminary intent of NMED is to issue the air quality operating permit on or before June 7, 2020.

Interested persons may obtain the draft operating permit, submit written comments, or request a public hearing on Operating Permit Number P208L-R3 by contacting Joseph Kimbrell at the New Mexico Environment Department, Air Quality Bureau, 525 Camino de los Marquez Suite 1, Santa Fe, NM 87505-1816.

Written requests for public hearing must state the nature of the issues proposed to be raised in the hearing. Comments must be based on the requirements of the applicable state and federal air quality regulations and the Clean Air Act. Comments or hearing requests must be received within 30 days after the public notice is published.
