Dear Secretary Kenney:

This letter is in response to the Environment Department's proposed methane rules recently released for public comment. I congratulate the administration's proactive approach to combating the terribly destructive impact climate change has had on our planet and our lives. Witnessing the recent fires, hurricanes and flooding in our country, and the rollbacks of environmental protections by the federal government, it is critical that New Mexico take steps now to minimize the damage already done and to help prevent future catastrophes.

As the former chair and current member of the Senate Conservation Committee and Water and Natural Resources Committee, I understand the importance of having strong regulatory oversight of environmental hazards. That is why I am concerned by the exemptions in the Department's proposed rules and express my support for their removal. As they are currently drafted, stripper wells and facilities that annually emit less than 15 tons of methane emissions would be exempt from regulation by the Department. The proposed rules will be less effective in removing much of the toxic pollution caused by methane emissions if the exemptions are adopted.

Eliminating the exemptions from the Department's rules will also allow New Mexico to increase its tax and royalty revenue by an estimated \$40 million per year. This revenue could be used to bolster the state's finances and provide additional resources to fund education and other critical needs of the state.

It is in New Mexico's best interests that the exemptions be eliminated from the proposed rules. Thank you for the opportunity to provide comments on this important issue.
