

12/12/14	Deadline for all parties to file Notices of Intent to Present Technical Testimony, pre-filed direct testimony and exhibits

3/20/15	Deadline for all parties to submit responses to pre-hearing motions

30 days after receipt of hearing officer's report	Deadline for submittal of exceptions to Hearing Officer Report and draft statement of reasons
Approximately 30 days after receipt of exceptions, at next regular Commission Meeting	Hearing Officer presents final proposed statement of reasons and report to Commission for review and approval
