The Surface Water Quality Bureau of the New Mexico Environment Department invites public comment on a draft update of two federally required planning documents: the **Statewide Water Quality Management Plan and the Continuing Planning Process**. Major proposed changes include: merging the two documents into one, providing greater detail on the process for developing Total Maximum Daily Loads (TMDLs), and adding the *Hydrology Protocol*, a methodology for distinguishing between ephemeral, intermittent and perennial streams that can be used to support changes to water quality standards.

If there is no hearing, the Commission will consider the document for approval at one of its regular open public meetings.
