Re: Request for EPA's review and approval of designated use amendments to San Isidro Arroyo, Mulatto Canyon, Arroyo Tinaja and Doctor Arroyo in McKinley County, New Mexico

Dear Mr. McQueen,

Pursuant to 20.6.4.15 NMAC, the State of New Mexico Standards for Interstate and Intrastate Surface Waters, Peabody Natural Resources Company ("Peabody") conducted a Use Attainability Analysis ("UAA") for four waterbodies within the Lee Ranch Mine in McKinley County, New Mexico. The UAA prepared by Peabody evaluated the extent of the natural low-flow conditions along the San Isidro Arroyo, Mulatto Canyon, Arroyo Tinaja and Doctor Arroyo within the Lee Ranch Mine site, not already evaluated in previous studies.

Peabody solicited public participation on the proposed amendments from March 13 through April 12, 2019 and held a public meeting on the Draft UAA and proposed water quality standards amendments on March 26, 2019. Subsequently, Peabody petitioned the Water Quality Control Commission ("WQCC") for a hearing on the proposed amendments on April 5, 2019. Public notice of the hearing was published in the New Mexico Register on July 30, 2019, and in the Albuquerque Journal and the Gallup Independent on August 2, 2019. A public hearing was held before the WQCC and a Hearing Officer on October 8, 2018. At the public hearing, Peabody and the New Mexico Environment Department presented technical testimony in support of the proposed rulemaking. No other party entered an appearance in this matter, and there was no public comment. The WQCC deliberated on October 8, 2019, at which time it voted unanimously to adopt Peabody's proposed amendments. The rule was filed with the State Records and Archives and became effective for State purposes on December 17, 2019.

In accordance with 40 CFR §131.20, the State of New Mexico is hereby submitting the UAA for San Isidro Arroyo and Tributaries within Lee Ranch Mine along with the WQCC's final order and statement of reasons approving the proposed amendments to 20.6.4 NMAC for EPA's review and approval. Also enclosed is the certification from the State Attorney General certifying the rule was adopted in accordance with the laws of the State of New Mexico.
