NEW MEXICO WATER QUALITY CONTROL COMMISSION NOTICE OF PUBLIC HEARING TO CONSIDER APPEAL OF THE ADMINISTRATIVE COMPLIANCE ORDER ISSUED TO CREEKSIDE DAIRY, LLC EDDY COUNTY, NM, WQCC 17-07 (A) The New Mexico Water Quality Control Commission (WQCC) will hold a public hearing on January 9, 2018, in Mabry Hall of the Jerry Apodaca Education Building, located at 300 Don Gaspar, Santa Fe, New Mexico 87501, to consider an appeal filed by Mr. Abel Villalpando dba Creekside Dairy and Creekside Dairy, LLC ("Petitioner") to Administrative Compliance Order No. GWQB 17-02 (CO) ("ACO") issued by the Ground Water Quality Bureau ("GWQB") to Mr. Villalpando and Creekside Dairy located at 7785 Roswell Highway, Lake Arthur, New Mexico 88253 ("Facility"). The Facility is a dairy facility discharging approximately 56,000 gallons per day of wastewater. The ACO imposes upon Petitioner civil penalties for violations of 20.6.2.3104, 20.6.6.8, and 20.6.6.10 NMAC, discharging without a ground water discharge permit. The public hearing will begin immediately following the Commission's regular business meeting, which starts at 9:00 AM. The hearing will be conducted in accordance with the Water Quality Act, NMSA 1978 Â§ 74-6-10, the Water Quality Control Commission Adjudicatory Procedures found in 20.1.3 NMAC, and all other applicable law. Participation by the General Public: Any member of the general public may present non-technical testimony at the hearing. No prior notification is required. A member of the general public may submit a written non-technical statement to the WQCC Administrator at any time prior to the close of the hearing. Those wishing to submit evidence pursuant to 20.1.3.19.E NMAC shall submit a list of witnesses, a description of the general subject matter of the testimony of each witness, and a list of exhibits to the WQCC Administrator no later than fifteen (15) days prior to the hearing.
