ORDER REQUIRING ADDENDUM

The New Mexico Water Quality Control Commission was scheduled to hold a public hearing in this matter beginning December 9, 2014. On December 3, 2014, the undersigned hearing officer ordered that the hearing be vacated and noted that the hearing would be re-scheduled by the Water Quality Control Commission. On January 13, 2015, the Water Quality Control Commission re-scheduled the hearing to begin on April 6, 2015. On January 19, 2015, notice of the hearing was published consistent with the Procedural Order entered in this matter. The notice, however, contained two errors related to certain deadlines.

- (d) The Addendum shall state that an individual with a disability who requires assistance or an auxiliary aid must contact the Personnel Services Bureau by March 30, 2015.

- (e) Any motions on evidentiary matters shall be filed no later than 5 p.m., March 27, 2015.

 Responses to evidentiary motions shall be filed no later than 5 p.m. April 3, 2015.
- (f) Unless specifically modified herein, the hearing for the above-captioned matter will be conducted consistent with the Procedural Order entered October 3, 2014.
