The New Mexico Water Quality Control Commission (WQCC) will hold a public hearing to consider proposed amendments to various sections of 20.6.4 NMAC, Standards for Interstate and Intrastate Surface Waters, beginning at 9:00 a.m. on October 13, 2015 through October 16, 2015, in Room 307 of the New Mexico State Capitol Building, 490 Old Santa Fe Trail, Santa Fe, New Mexico. In the event that more time is needed after 5:00 p.m., the hearing will move across the street to the P.E.R.A. Building, Apodaca Hall, at 1120 Paseo de Peralta, Santa Fe, NM.

The proposed amendments, docketed as WQCC 14-05 (R), include amendments proposed by the New Mexico Environment Department's (Department) Surface Water Quality Bureau, as well as amendments proposed by Amigos Bravos, Peabody Energy Corporation, Freeport-McMoRan Chino Mines Company and San Juan Water Commission. Proposed amendments include revisions to various definitions, use attainability analysis requirements, uses and criteria for unclassified waters and some classified segments, provisions for site-specific criteria and other provisions. The petitions and proposed amendments may be viewed on the Department's website, at www.env.nm.gov/swqb /TriennialReview/2013/, or during regular business hours by contacting Pam Castaneda, Commission Administrator, 1190 S. St. Francis Drive, Room S-2102, Santa Fe, New Mexico 87502, (505) 827-2425.

The hearing will be conducted in accordance with the New Mexico Water Quality Act, NMSA 1978, � 74-6-6, the Guidelines for Water Quality Control Commission Regulation Hearings (Guidelines), the Procedural Order, issued August 7, 2015, and the Scheduling Order, issued July 10, 2014, modified on January 30, 2015, and modified again on June 9, 2015. A copy of the Guidelines, Procedural Order and Scheduling Orders are available on the Department's website or may be obtained from the Commission Administrator at the address and phone number above. Notice of Hearing of WQCC 14-05 (R) was originally published on October 31, 2014, and then again on April 6, 2015 as a result of the hearing being moved to June 9, 2015; however, the date of the hearing has now been changed to October 13, 2015, therefore this notice is being issued. All current parties submitted their respective Notices of Intent to Present Technical Testimony by December 12, 2014. All interested persons will be given a reasonable opportunity at the hearing to submit relevant evidence, data, views and arguments, orally or in writing, to introduce relevant exhibits and to examine witnesses testifying at the public hearing.

Persons desiring to present technical testimony at the hearing must file with the WQCC a written notice of intent. The notice of intent to present technical testimony shall:

o identify the person for whom technical testimony will be presented;

o identify each technical witness the person intends to present and state the qualifications of that witness, including a description of their education and work background;

o attach the full direct testimony of each technical witness, which shall include an express basis for all expert opinions offered;
