Bill Olson, Acting Chair, called the meeting of the WQCC to order at 9:05 a.m.

Item #1 Roll Call

Sally Worthington took roll and noted a quorum was present.

Item #2 Approval of Agenda

Agenda Item #4 moved up to Agenda Item #3 and following items re-numbered.

ACTION: Commissioner Glass moved to approve the agenda as amended.

Commissioner Brandvold seconded. Motion carried unanimously.

Item #3 Opening of a 30-day public comment on the draft Upper Rio Grande Part II (Cochiti to Pilar, NM) Watershed TMDLs, presented by NMED SWQB

Jennifer Ickes, TMDL Team Leader for the Surface Water Quality Bureau, stated they would like to open up for public comment the Upper Rio Grande Part II TMDLs which cover the area of Cochiti Reservoir to Pilar, NM. The Public Comment Period will open today, January 11, 2005 and run until February 10, 2005 at 5:00 PM. The TMDLs are available here today and were posted on the NMED/SWQB website, mailed to SWQB mailing lists, and legal notices were placed in newspapers. The Upper Rio Grande Part II TMDL public meeting is scheduled for Tuesday, January 25, 2005 from 6-7 PM in Espanola, NM. The SWQB plans to seek approval of the final draft documents at the April 12, 2005, WQCC meeting. They also have additional TMDLs that are going to open between now and the next meeting and they will be either mailed or emailed to the Commissioners. They will be seeking approval on these additional TMDLs during April.

Item #4 Continuation of deliberation and action on Triennial Review of Standards for Interstate and Intrastate Surface Waters, 20.6.4 NMAC (WQCC 03-05 (R))

Acting Chair, Bill Olson, initiated the return to the process of deliberation continued from the December, 2004 meeting. Chair Olson requested that the minutes reflect the remarkable job done by Hearing Officer Felicia Orth and the Commission wholeheartedly agreed. Attachment A of the Hearing Officer's Report served as basis for the deliberations. The Commission concluded deliberations, which began on November 9 and 10, 2004 and continued on December 14 & 15, 2004; the Standards were adopted as amended. Commissioner Hutchinson asked that his objections be noted in the Final Order and Statement of Reasons. The Final Order/ Statement of Reasons will include information on specific actions taken during the deliberations.
