The meeting was called to order by Mr. Goldstein at 9:00 a.m.

Item 1. Roll Call:

The Commission administrator took roll and noted a quorum was present.

Item 2. Approval of Agenda

The Commission agreed that Agenda Item 7 would be heard in place of Agenda Item 5 and that Items 5 and 6 would be heard after Item 7.

Item 4.	Commission approval of the Open Meetings Act Resolution of 2009.

Item 7.	Announcement of Commission decision in re: WQCC 03-12 (A) and WQCC 03-13 (A) (Consolidated), In the Matter of the Appeal of Supplemental Discharge Permit for Closure, DP 1341, for Phelps Dodge Tyrone, Inc., Petitioner. Jim Norton, Acting Chair and Sally Malave, Asst. Atty. General, Commission Counsel.

Commissioners Chavarria and Flowers were not participants in Item 7 because they did not attend the hearing in this case.

The Acting Chair introduced Commissioner Johnson who set out the Commission's decision in in this consolidated case.

Ms. Johnson noted that the initial issues to be addressed were pending motions, the first from the Department requesting a ruling from the Commission that the Water Quality Act protect all groundwater in the State except private, isolated groundwater and that §74-6-5 (E) (3) of the Act does not apply to the issuance of DP-1341.

Action: Ms. Johnson moved that the Department's motion be denied. Mr. Sloane seconded.

Ms. Johnson then moved on to the second motion, which was filed by Gila Resources Information Project (GRIP), requesting that the Commission adopt three general policies to help guide the Commission's determination of whether the Tyrone mine site is a place of withdrawal of water for present or reasonably foreseeable future use.

The Commission finds that GRIP's motion does not resolve the central question in this proceeding of where the effects of Tyrone's discharges will be measured and ignores the Court of Appeals' rejection of "such a broad and impractical interpretation of the Act."

Ms. Johnson then mentioned the applicability of the Water Quality Act (Act) and Water Quality Control Commission regulations, she went on to note that the purpose of the Act is to abate and and prevent pollution in "all water, including water situated wholly or partly within or bordering upon the State, whether surface or subsurface, public or private, except private waters that do not combine with other surface or subsurface waters." (quoting §74-6-2 (H) of the Act).

Ms. Johnson then noted a number of additional issues relating to the Act and its provisions as well as findings by the Commission.

Action: Ms. Johnson moved, based on the Commission's findings and conclusions, that the Commission order (1) that NMED shall identify places of withdrawal of water for present or reasonably foreseeable future use and identify appropriate locations at which the effect on groundwater discharges covered by DP-1341 shall be measured; (2) that the Department and Tyrone shall negotiate on the appropriate systems model and modeling parameters to determine the effectiveness of DP-1341 conditions four and seventeen; (3) the Department shall determine the effectivness of DP-1341 conditions four and seventeen to prevent and reduce groundwater contamination at the identified places of withdrawal of water for present or reasonably foreseeable future use; and (4) that the parties shall comply with these terms within eighteen months of the issuance of the Commission's written order. Item 5. Petition for review in re: WQCC 08-15 (A), Peabody Energy Petition for Review of NMED Surface Water Quality Bureau's Directive to the NM Energy, Minerals and Natural Resources Department's Mining and Minerals Division regarding Application of Surface Water Quality Standards to Permanent Impoundments at Coal Mines. Stuart Butzier, Esq., Modrall Law Firm for

Petitioner; Eric Ames, NMED/OGC.

Mr. Butzier briefly discussed the petition for review and stated that, after conferring with Mr. Ames, it was agreed that a workable process with respect to this matter would be for the Commission to appoint a hearing officer for the purpose of setting out scheduling dates in this proceeding and conduct the hearing. Mr. Butzier then requested that the Commission not set a hearing at this time but appoint a hearing officer to set the procedural schedule and preside over the hearing.

There was Commission discussion relating to the ramifications of naming a hearing officer to conduct the hearing, prepare a report for the Commission and then make the transcript of the hearing available to the Commission for review prior to deliberating this matter.

Discussions continued regarding various hearing scheduling alternatives available to the Commission.

- Action: Mr. Vigil moved that WQCC 08-15 (A) be tabled until the Commission's next meeting. Mr. Dominguez seconded. The motion passed unanimously.
- Item 6. Motion to Stay Permit Conditions Pending Appeal in re: The Matter of the Appeal by Sebastiao Faria (Faria Dairy East) of Permit Conditions in re: DP 923, WQCC 08-09 (A). Pete Domenici, Esq., Domenici Law Firm for Sebastiao Faria; Adolfo Mendez, NMED/OGC.

Mr. Mendez stated that Mr. Domenici had agreed that he, Mr. Mendez, would appear on behalf of both parties to set out the agreements that had been reached in this matter. Mr. Mendez referred the Commission to the NMED and Petitioner Stipulated Scheduling Order for Appeal Petition and Stay of Permit Conditions Pending Appeal document which had been forwarded to all members.

There was discussion regarding options available to the Commission with respect to procedural issues in this case.

Mr. Chavarria brought up the question of the triennial review and the possiblity of tribal members meeting with the Department to discuss the review. Marcy Leavitt, Water and Waste Management Division Director for the Department stated that it was her understanding that Pamela Homer, Water Quality Standards Coordinator for the Surface Water Quality Bureau, has scheduled meetings with

tribal representatives. There was a brief discussion relating to the State's jurisdiction over tribal water resources.
