The meeting was called to order by Mr. Solomon at 9:00 a.m.

Item 1. Roll Call.

Roll was taken, it was noted that a quorum was present.

Item 2. Approval of Agenda.

- Action: The Commission discussed switching Items 6 and 7. Mr. Tso moved Commission adoption of the Agenda as amended, moving Item 7, motion for hearing on DIGCE's Motion to Stay in WQCC 09-13 (R) because a Stipulated Motion to Stay had been filed, to Item 6. Mr. Gatterman seconded. The motion passed unanimously.
- Item 3. Approval of January 11, 2011 meeting minutes.
- Action: Meeting minutes were not available and will be taken up at the next WQCC meeting.
- Item 4. Status update and scheduling of public hearing or meeting to approve consolidation and revision of the Water Quality Management Plan and Continuing Planning Process. Eric Ames, NMED/OGC, Pam Homer, NMED Surface Water Quality Bureau.
- Action: After Commission discussion, Mr. Glass moved to set hearing for the next WQCC meeting in May with NMED documents submitted by the end of next week (April 15, 2011). Mr. Gatterman seconded. The motion passed unanimously.
- Item 5. Hearing, continued, and possible deliberations in WQCC 10-10 (R), Petition for Rulemaking for Procedures Governing State Certification of Federal Permits under the Clean Water Act, NMED, Petitioner. Charles de Saillan, NMED/OGC for NMED; Megan Anderson and Rachel Conn, Amigos Bravos; Louis Rose, Montgomery & Andrews.
- Action: A recap of the hearing was given by Mr. de Saillan. After Commission discussion, Mr. Vigil moved to close the record and adopt the rules as amended and agreed to by Mr. de Saillan, attorney for NMED, Ms. Anderson and Ms. Conn, attorneys for Amigos Bravos, and Louis Rose. Item 6. (formerly Item 7). Motion Hearing—DIGCE's Motion to Stay in WQCC 09-13 (R), Amendments to 20.6.2 NMAC, Dairy Regulations. T.J. Trujillo and Dalva Moellenberg for Movants; Chuck Noble and Misty Braswell, MNMED/OGC; Jonathan Block and Bruce Frederick for the Coalition; Melanie Carver, NM Atty. General's Office, Commission Counsel.

Action: Mr. Noble distributed Stipulated Motion to Stay hearing agreed to by all parties. The Commission discussed with parties repercussions of delaying the motion hearing. Mr. Glass moved to table the motion hearing. After discussion, Mr. Glass amended his motion and moved to delay motion hearing until the July WQCC meeting. Mr. Tso seconded the motion. After further discussion the motion was withdrawn and Mr. Sanders moved to delay consideration of the Motion to Stay until the June WQCC meeting. Mr. Dominguez seconded the motion.

Item 7. (formerly Item 6). Motion Hearing—Cattle Growers Association's Motion to Stay in WQCC 10-01 (R), Designation of Outstanding National Resource Waters. Dan Dolan for Movants, Tannis Fox, NMED/OGC, Erik Schlenker-Goodrich for River Groups; Jay Tutchton and Samantha Ruscavage-Barz for WildEarth Guardians; Melanie Carver, NM Atty. General's Office, Commission Counsel.

Action: The Commission discussed Motion to Stay and Motion to Strike and Motion to Continue. The Commission heard from attorneys for the River Groups and WildEarth Guardians to discuss the Motion to Strike the Cattle Grower's Brief.

Mr. Glass moved to Strike Cattle Grower's Brief. Mr. Sloane seconded. The Commission had extensive discussions on how to proceed and repercussions of various options on how to proceed given by Commission Counsel.

The Commission held further discussions on how to proceed. Mr. Sanders moved to allow the River Groups and WildEarth Guardians to file a sur-reply to the Cattle Grower's Brief and to continue the proceeding until that time and to proceed with the motion hearing on the Motion to Stay. Mr. Dominguez seconded. The Commission held further discussions and Mr. Sanders withdrew his motion.

Following further discussion on how to proceed, Mr. Sanders moved to continue the proceeding and to allow for witnesses with a scheduling order providing an opportunity for the River Groups and WildEarth Guardians to file a sur-reply to the Cattle Grower's Brief, the scheduling procedure to include dates filings are due and limiting the evidence to the established prongs for a stay.

The Commission held further discussions and agreed to break for 15 minutes to give all parties an opportunity to agree to a scheduling order outlined by Commission Counsel.

After break the Commission further discussed options on how to address Motion to Strike by River Groups and WildEarth Guardians and the late filing by the Cattle Growers. The River Groups and WildEarth Guardians discussed reasons for their Motion to Strike. There was further Commission discussion of options on how to address the Motion to Strike and options for sanctions and/or for the late filing by the Cattle Growers. Legal options were given by Commission Counsel.

- 2. NMED, WildEarth Guardians, and River Groups may respond to the Cattle Growers Brief by April 29, 2011.
- 3. Exhibit and Witness lists, Demonstrative props, and Exhibits are due by all parties by April 22, 2011.
- 4. Rebuttal Witnesses and Exhibits are due by all parties by April 26, 2011.
- 5. Service is to be by email to all parties.
- 6. If any of the deadlines are missed by any of the parties, documents will be excluded and opportunity to respond is excluded.
- 7. If a continuance is requested by any party, that party concedes its argument.
- 8. The scope of testimony is limited to stay prongs 2, 3, and 4, and stay prong 1 is not open to new evidence or new witnesses as set forth in Section 502.B of the rulemaking hearing guidelines.
- 9. Argument addressing Prong 1 is limited to a demonstrative prop that cites to the record and is due April 22, 2011
- 10. All evidence and exhibits are to contain citations to the record.
- 11. Objections to any evidence and exhibits will be heard at the hearing.
- 12. No other written documents will be allowed.
- 13. Mr. Sanders will serve as Hearing Officer.
