The meeting was called to order by Mr. Goldstein at 11:00 a.m.

Item 1. Roll Call:

The Commission administrator took roll and noted a quorum was present.

Item 2. Approval of Agenda

It was noted that Item 6 on the initial agenda has been removed and Item 6 on the revised agenda is now WQCC 08-12 (R), Petition for Nomination of Caballo Reservoir and portions of the Rio Grande for ONRW status.

Action: Mr. Sloane moved approval of the agenda as amended.

Mr. Lewis seconded. The motion passed unanimously.

Item 3. Approval of meeting minutes of November 12, 2008.

Action: Mr. Dominguez moved to approve the minutes as presented.

Mr. Glass seconded. The motion passed unanimously.

Item 4. Approval of Order and Statement of Reasons and record closure in

WQCC 07-09 (R), Utility Operator Certification Advisory Board.

Adolfo Mendez, NMED/OGC.

Mr. Mendez noted that a minor typographical error in the text of the document had been corrected in the document and also that the Affidavit of Publication of the Notice of Public Hearing in this case has been filed. He requested that the record be closed and that the Order and Statement of Reasons, as corrected, be signed by the Chair.

Action: Mr. Glass moved the adoption of the Order and Statement of Reasons,

as corrected. Mr. Hutchinson seconded.

Leslie Barnhart, NMED/OGC.

Ms. Barnhart briefly explained the Triennial Review and stated that the Department proposes the Commission designate Felicia Orth as hearing officer in this matter.

Action: Mr. Glass moved that the Commission grant the petition as submitted.

Mr. Sloane seconded. The motion passed unanimously.

Item 6. Request for hearing in re: Petition for Nomination of Caballo Reservoir and portions of the Rio Grande for ONRW status, WQCC 08-12 (R). Jerry W. Nivens, James M. Massengill, James Goton and Mike Slater.

Mr. Nivens, speaking on behalf of all of the petitioners, explained why the group felt it was necessary to have the referenced waters designated as an Outstanding National Resource Water.

A lengthy discussion by and among the Commission, Mr. Nivens and NMED staff ensued. Following discussion, it was established that the Commission felt it was necessary for Petitioners to publish public notice of their intent with respect to the nomination of the referenced waters prior to the Commission setting a hearing in this matter.

Action:

Mr. Sloane moved that the Commission table the Petition for Nomination of Caballo Reservoir and portions of the Rio Grande for ONRW status, WQCC 08-12 (R), until the first Commission meeting following the 2009 Legislative Session, with the understanding that Petitioners will publish public notice of their Petition and will also endeavor to obtain opinions from the local population regarding this proposed nomination. Mr. Von Gonten seconded.
