

NOTICE OF NON-APPEARANCE

The Water Quality Control Commission (“Commission”) scheduled oral closing argument and deliberations in WQCC 12-01(R) 20.6.2 NMAC - The Copper Rule for September 10, 2013. Counsel for Amigos Bravos respectfully submits this Notice of Non-Appearance for the Commission’s September 10, 2013 meeting. On June 26, 2013, the date to submit post-hearing brief was extended until August 16, 2013 and then further extended until August 22, 2013, which changed the date for the Commission’s deliberations. Counsel for Amigos Bravos had a prior longstanding commitment for September 10, 2013 and she cannot attend the Commission’s meeting. 
