RE: Emergency Powers Order 2016-1 and 2016-2 Notice of Non-Compliance

Mr. Whistle:

In response to the boil water advisory that was issued on June 2, 2016 and extended water outages at the Morningstar Water Supply System (System No. NM3510524), the New Mexico Environment Department (NMED) issued Emergency Orders (EO) 2016-1 and 2016-2 on June 17 and 24, 2016, respectively. These EOs require the Morningstar Water Supply to take specific actions to address the water emergencies at the water system.

On September 1, 2016 the NMED allowed the boil water advisory at the Morningstar Water Supply System to be lifted; however, there are several outstanding requirements of EOs 2016-1 and 2016-2 that must be completed.

The NMED's Drinking Water Bureau (DWB) has evaluated Morningstar Water Supply System's compliance with the requirements of the EOs as of November 4, 2016 and is providing you with the attached Notice of Non-Compliance.

As of November 4, 2016 the Morningstar Water Supply has accumulated the following fines:

Copies this notice and verification of the proper distribution of these public notifications must be provided to DWB no later than 24 hours after the notifications have been distributed. The contents shall include but are not limited to, current status of the Boil Water Advisory, current status of distribution system deficiencies and corrective actions being taken to repair these deficiencies, current status of the proposed interconnection to the Farmington Water System, current status of the construction of the pumping station which will permanently provide Farmington water to System customers, information regarding water conservation measures that are currently in place, and information regarding any applicable timeframes for completion of the final interconnection with the Farmington Water System. Verification of the proper contents and distribution of these public notifications must be provided to DWB no later than 24 hours after the notifications have been sent out.

However, in the status update letter that was provided to Mr. Whistle, NMED DWB indicated that the distribution deficiency status report was not accepted. For the week ending August 26, 2016 completely failed to submit a weekly update as required by Emergency Order 2016-2. Additionally, the Emergency Order specifically requires that these notifications be sent to system customers no later than noon on Friday of each week. The Emergency Order also specifically requires that the notification be distributed in a manner, including but not limited to all local broadcast media, San Juan County Emergency Management, and phone calls or mail outs to all customers of the System. Due to the fact that not all of the notifications, specifically the phone and/or mail outs were not completed by Noon on each Friday, Morningstar Water Supply has not complied with this portion of Requirement #5 for the weeks of Friday July 1, 2016, Friday July 8,

Additionally, verification of the proper contents and distribution of these public notifications must be provided to DWB no later than 24 hours after the notifications have been sent out. As of the date of this status update, DWB has not received full verification of required distribution. Due to the fact that the Boil Water Advisory for the Morningstar System was lifted on September 1, 2016, the requirements for these weekly updates also ended on September 1, 2016.
