NOTICE OF INTENT TO PRESENT TECHNICAL TESTIMONY

The Air Quality Bureau (“Bureau”) of the New Mexico Environment Department (“NMED” or “Department”) submits this Notice of Intent to Present Technical Testimony (“NOI”) for the public hearing currently scheduled for May 28, 2021.

1. The person for whom the witness will testify.

The New Mexico Environment Department, Environmental Protection Division, Air Quality Bureau.

2. The name and qualifications of each technical witness.

Michael Baca. Mr. Baca is the Staff Manager of the Control Strategies Section of the Air Quality Bureau. He has worked for NMED for 16 years and has been with the Bureau for approximately 13 years. He holds a B.A. degree in Chemistry from Carleton College. His resume is attached as Exhibit 1.

Kerwin Singleton. Kerwin Singleton is the Chief of the Planning Section of the Air Quality Bureau and will be available to answer questions; he will not provide technical testimony. He has 34 years of experience in the environmental field, including 14 years with the Department. In addition to his work for the Air Quality Bureau, Mr. Singleton has worked in industry and government as an environmental engineer. Mr. Singleton holds a B.S. degree in Chemical Engineering from the University of Missouri - Columbia. His resume is attached as
